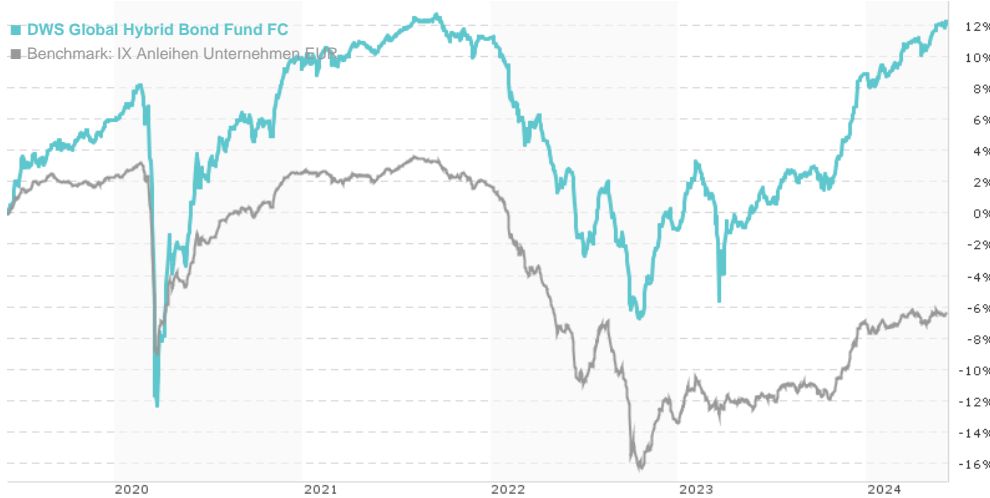

Investment strategy

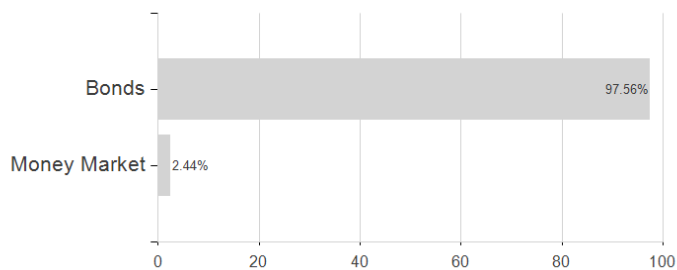
To achieve this, the fund invests predominantly in hybrid bonds. Hybrid bonds are equity-like, subordinated corporate bonds with very long maturities or without a maturity date, they can be terminated by the issuer as of a previously defined date. In terms of their characteristics, they lie between equities and fixed rate securities. The selection of the individual investments is at the discretion of the fund management. The fund promotes environmental and social characteristics or a combination of these characteristics without pursuing an explicit ESG and/or sustainable investment strategy. Investment goal

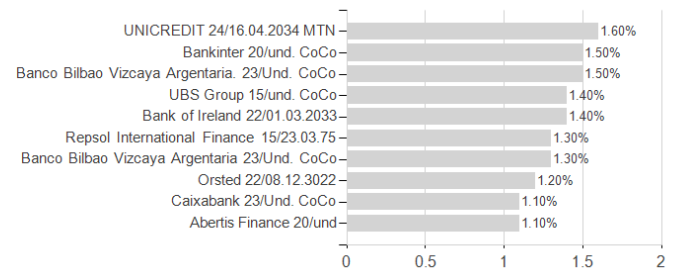

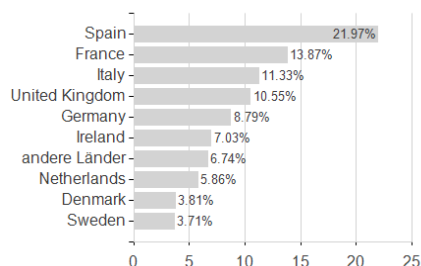

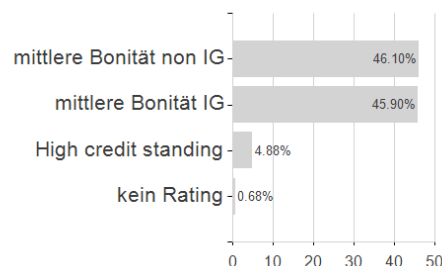
