Investment strategy

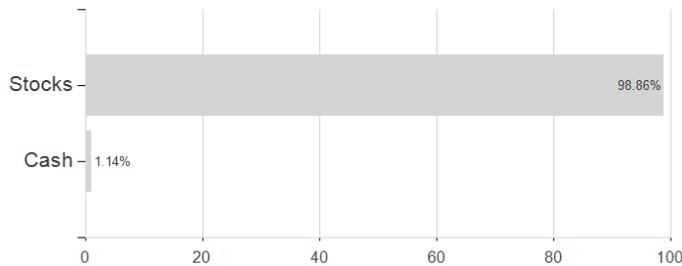
The Fund will invest at least 50% of the Fund's total assets in equities of companies that exhibit positive or improving environmental, social and governance (ESG) characteristics. The Fund is also permitted to invest to a lesser extent in shares of companies elsewhere in the Asia Pacific region (other than Australia) or in other markets which the investment manager believes have the potential to benefit from the economic growth and development of the Asia Pacific region. Furthermore, it may invest in shares of companies that exhibit less positive environmental, social and governance (ESG) characteristics.

Investment goal

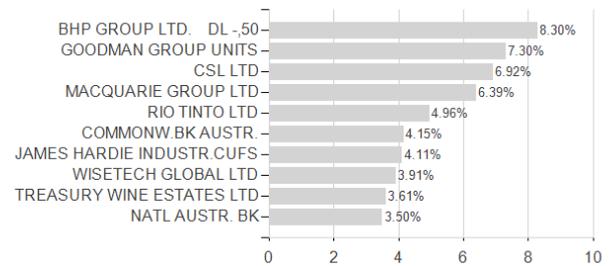

The Fund invests at least 70% of its total assets (excluding cash and cash equivalent assets) in the shares of companies incorporated in, exercising the predominant part of their economic activity in, or quoted or traded on stock exchanges in Australia.

Assessment Structure

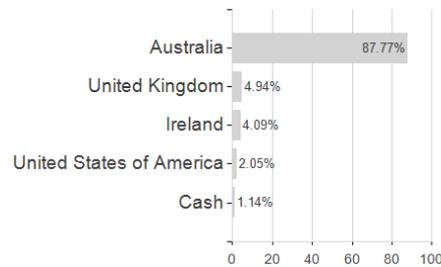

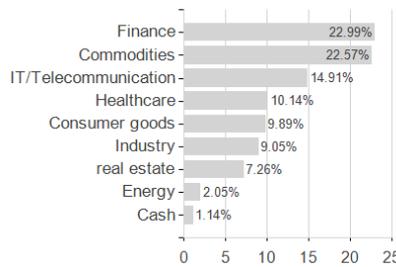
