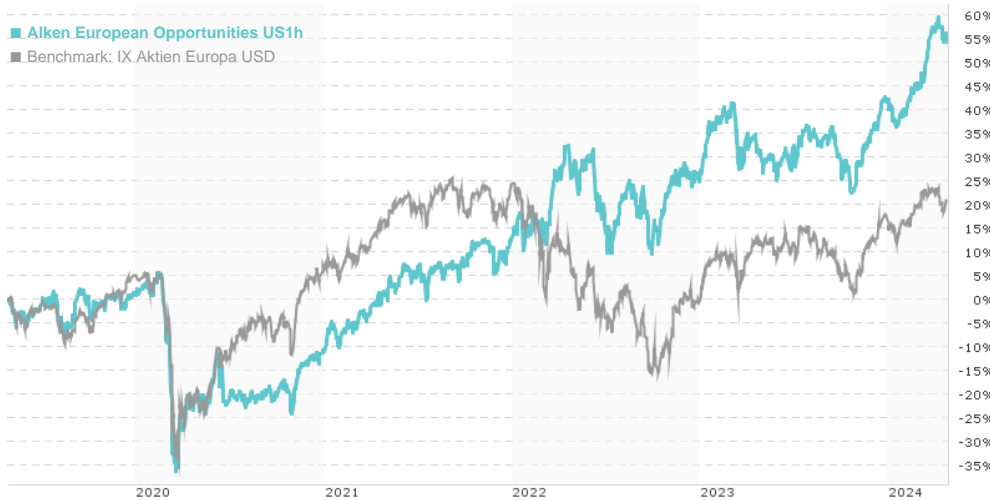

Investment strategy

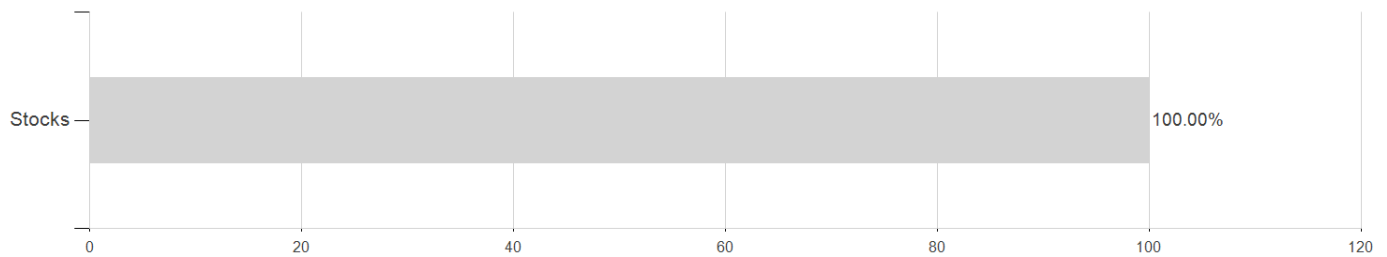

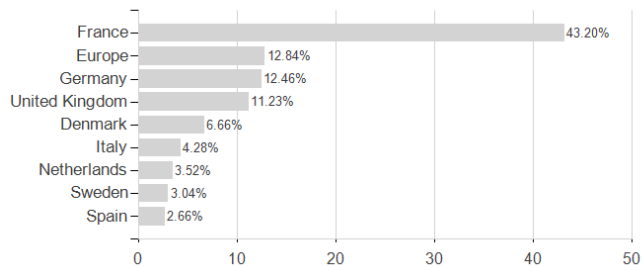
