Investment strategy

LINK is designed to provide exposure to the performance of Chainlink (LINK) (the underlying asset(s)). Price data (in USD) from CryptoCompare (<https://www.cryptocompare.com/>) is used to calculate the price of the reference asset. The securities are only issued directly to authorised participants (who are generally regulated financial institutions) in return for delivery of the underlying asset(s) which must be newly minted or sourced from a defined list of crypto currency exchanges. All assets relating to the securities are secured by way of a pledge to a collateral agent acting on behalf of investors.

Investment goal

This product is a non-interest bearing bond under Swiss law that is fully secured by holdings of Chainlink (LINK) or other assets denominated therein. This product's primary listing is BX Swiss but it may be listed on additional exchanges and MTFs. Typically, those products are known as exchange traded products (ETPs).
