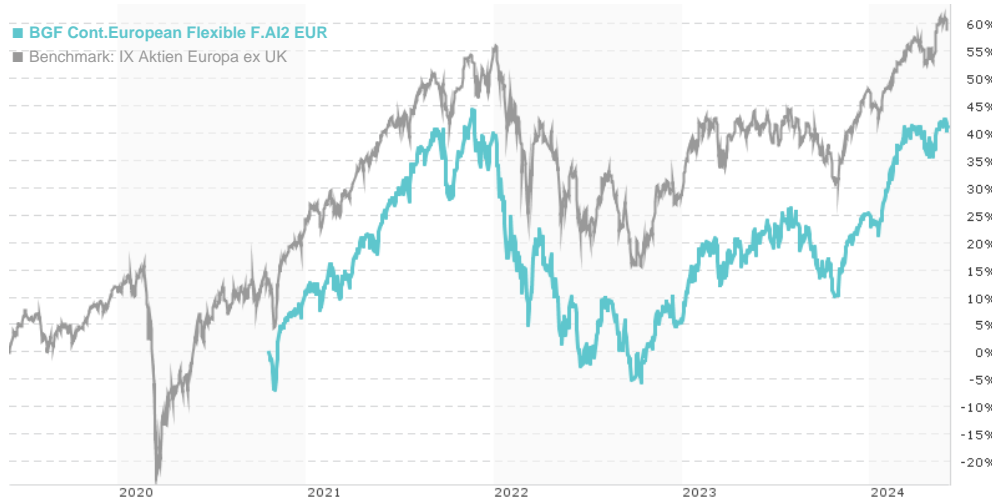

Investment strategy

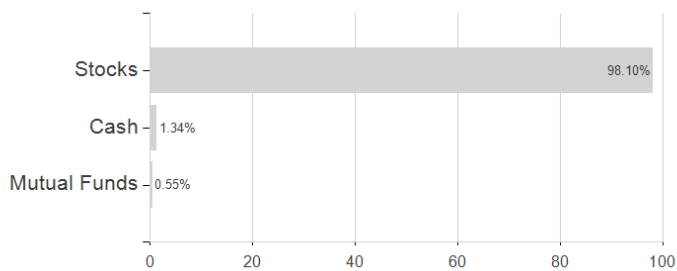

Investment goal

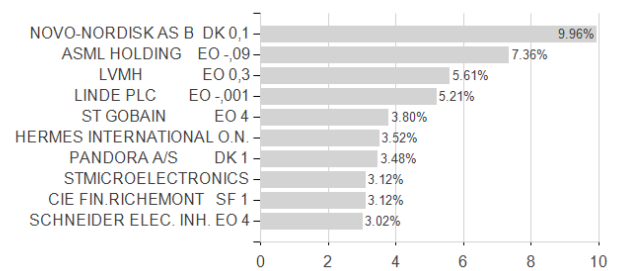

The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of companies domiciled in, or the main business of which is in, Europe excluding the United Kingdom.

Assessment Structure

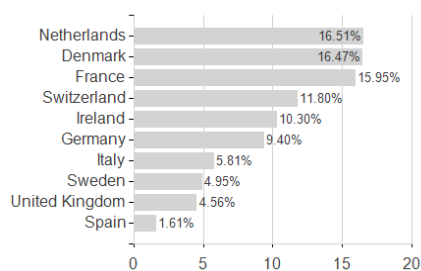

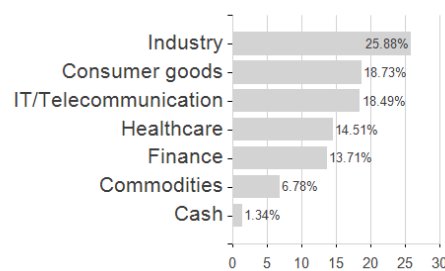
