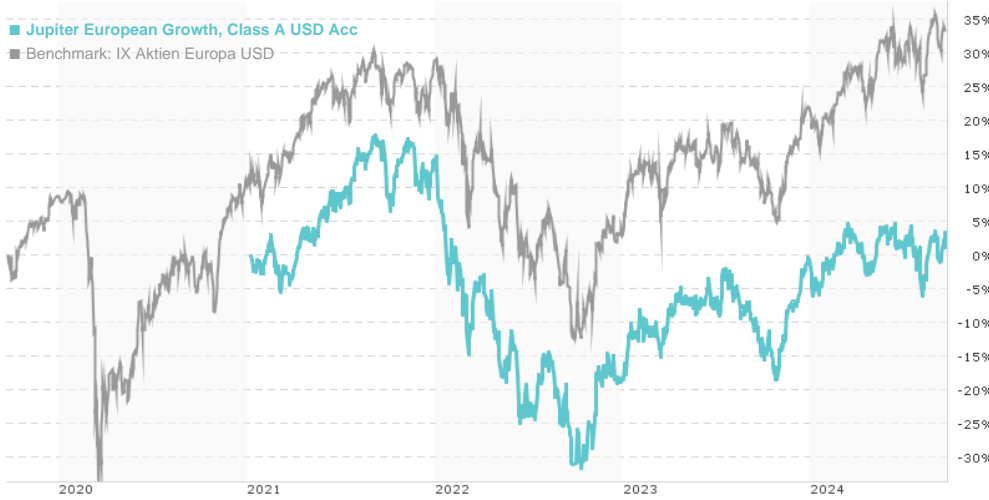

Investment strategy

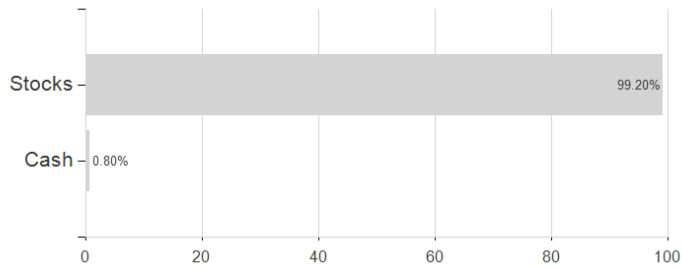

Investment goal

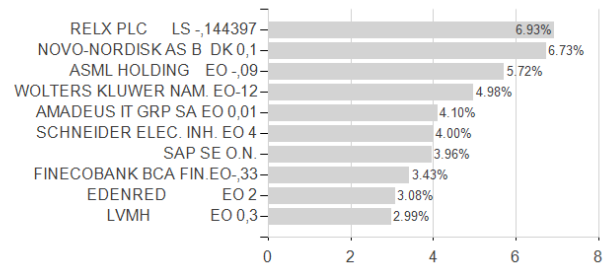
The Fund's objective is to achieve long term capital growth by exploiting special investment opportunities in Europe.

Assessment Structure

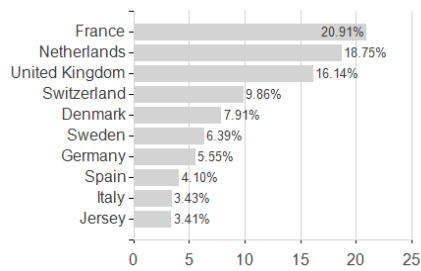

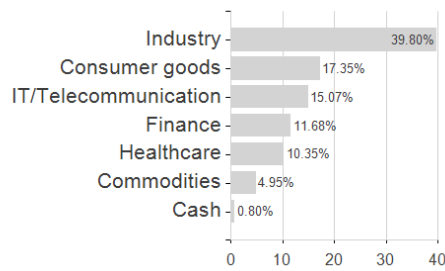
