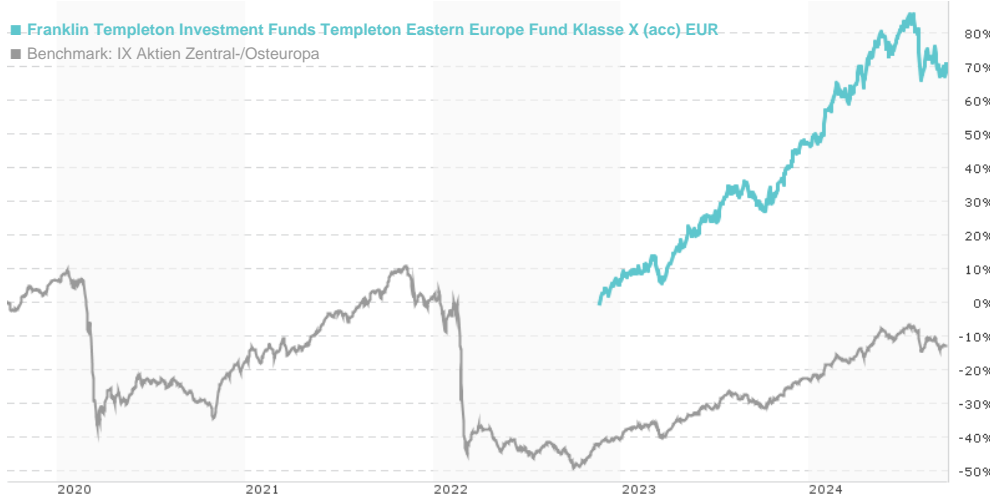

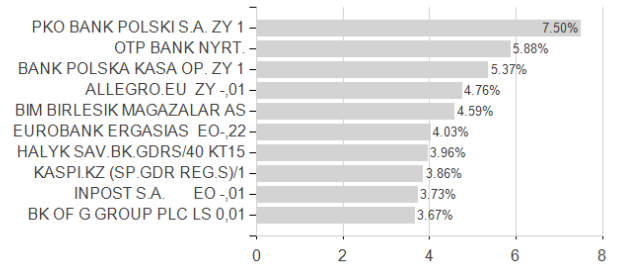
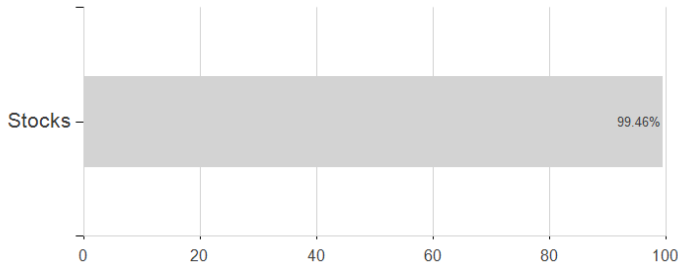
Investment goal
