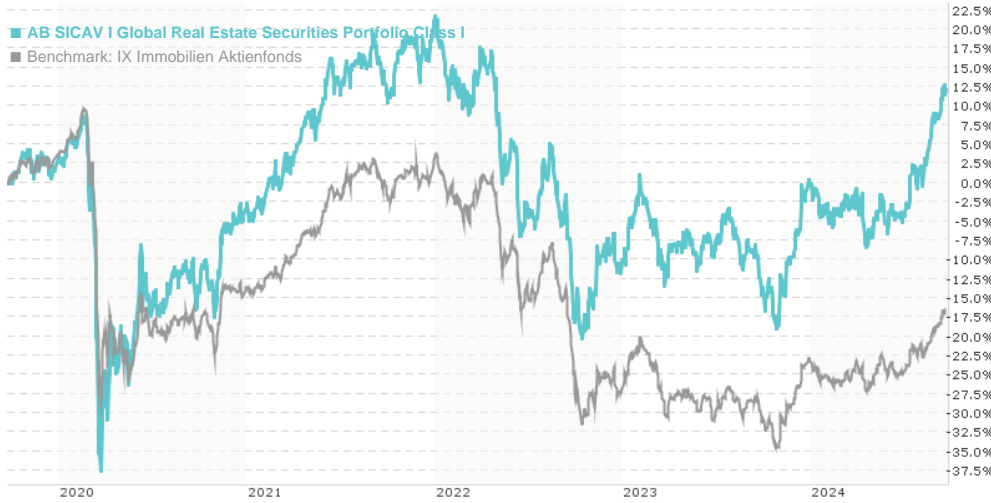

Investment strategy

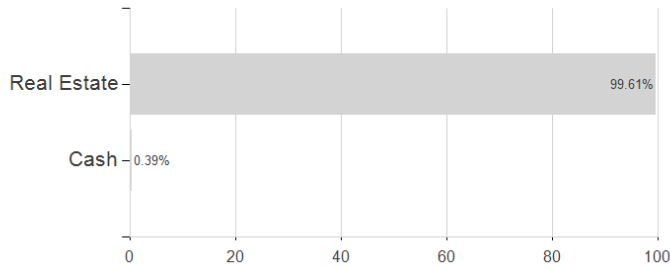

Investment goal

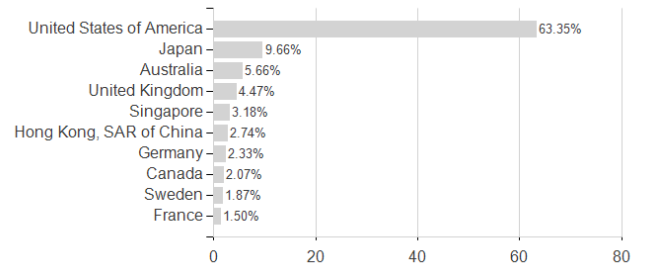

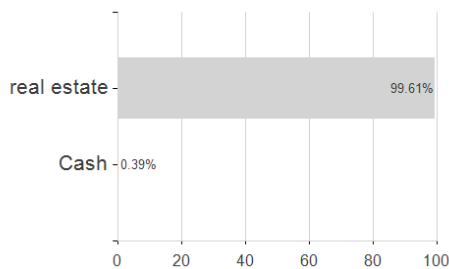

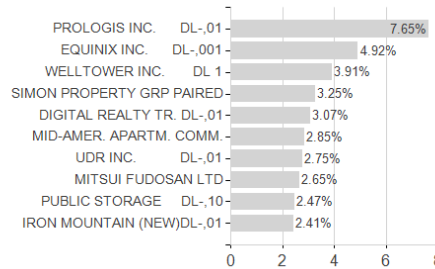
