OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through a combination of income and capital growth (total return) while seeking to moderate volatility.

Investment policy

Under normal market conditions, the Fund typically invests in equity securities and debt securities of any credit quality (including below Investment Grade debt securities) of companies that are organized, have substantial business activities, or are impacted by developments, in China. These companies may be of any market capitalization and industry.

The Fund may also seek exposure to other asset classes such as commodities, real estate, currencies, interest rates and any other eligible indices. The Fund is not limited in its exposure to equity and debt securities. The Fund may utilize all markets where these equity securities are traded, including the China Connect Scheme and the China A-share and H-share equity markets of both China and offshore equity markets. The Fund may also invest in China through any RQFII programs that may be held by the Management Company or an affiliate.

The Fund may utilize all bond markets where these debt securities are traded including Bond Connect.

The Fund may invest in, or be exposed up to 20% in structured products such as asset- and mortgage-backed securities (ABSs/MBSs).

The Investment Manager uses fundamental research and a proprietary quantitative analysis to flexibly adjust investment exposures across various asset classes with the goal of building an optimal risk/return portfolio in all market conditions.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes (including to take synthetic short positions).

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

60% MSCI China All Shares / 40% Bloomberg Barclays China Aggregate Treasury Index used for performance comparison, risk measurement, and volatility measurement.

Fund currency

The reference currency of the Fund is USD.

Share class currency

The reference currency of the share class is USD.

Distribution policy

This share class is a distributing share class. Dividends may include income, realized capital gains and/or be paid out of capital.

Redemption

Shares may be redeemed on any day on which banks in Luxembourg, Hong Kong, Shanghai, and Shenzhen are open for business and the New York Stock Exchange is open.

Terms to understand

Asset-backed securities: Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

Below Investment Grade Securities: Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

Bond Connect: A mutual market access scheme that allows investors from mainland China and overseas to trade in each other's respective debt securities markets.

China A-share equity markets: Comprised currently of portions of both Shanghai Stock Exchange and the Shenzhen Stock Exchanges. A-shares are shares of mainland China-based companies.

China Connect Scheme: A trading-linked program for Chinese securities developed by, among others, the Hong Kong, Shanghai, and Shenzhen stock exchanges.

China H-share equity markets: Exchanges or markets outside of Mainland China where H-shares of Chinese companies are traded.

Debt securities: Securities that represent the obligation to pay a debt, with interest.

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Duration: A measure of how much the price of a fixed-income asset will fluctuate as a result of changes in the interest rate environment. Securities with a higher duration are typically more sensitive and can have greater price fluctuations in case of changes in the interest rates.

Equities: Securities that represent an ownership stake in a company.

Investment Grade Securities: Debt securities rated at or above BBB-/Baa3.

Mortgage-related securities: Debt securities representing an interest in a pool of mortgages.

Offshore equity markets: Exchanges or markets located in the U.S., Hong Kong, the United Kingdom, Singapore, Korea, and Taiwan.

Other investment purposes: In line with the Fund's investment objective and policy, means to gain exposure and/or to manage duration.

SFDR: Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector.

Volatility: Measure of the pricing behavior of a security.

RISK AND REWARD PROFILE



What does this risk indicator mean?

This synthetic risk and reward indicator (SRRI) scale rating indicates how the Fund may perform and the risk of losing some or all of your capital. Generally the potential for higher gains also means a larger risk of losses. The lowest category does not mean a risk free investment.

The above rating is an estimate, not a guarantee. It is calculated using industry-standard methods and is based on medium-term volatility (how sharply the Fund's actual or estimated share price has gone up and down over five years).

Why is this Fund in this category?

The Fund is not guaranteed in capital. The Fund is invested in both equities and debt securities which are subject to variations up or down that can generate gains or losses.

Risks materially relevant to the Fund but not adequately captured by the SRRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Allocation risk: The Fund's allocation to various asset classes may change over time and this could impact the performance of the Fund positively or negatively.

China Liquidity risk: The Portfolio invests in China through a RQFII quota and so is subject to the liquidity risks associated with investment under a state-supervised quota system. The Portfolio may additionally invest in domestic Chinese equity markets through the Shanghai-Hong Kong Stock Connect Scheme, and so is subject to the custody, execution and liquidity

risks of investing in securities via this newly established market infrastructure.

China Market risk: The Fund will primarily invest in domestic securities of issuers located in China and so will be directly affected by volatility in securities markets in China and changes in the economic and political climate in China generally. The legal and regulatory framework for capital

markets in China may not be as well developed as those of developed countries and entails additional risks.

Counterparty risk: If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

CHARGES

The charges you pay are used to pay the cost of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

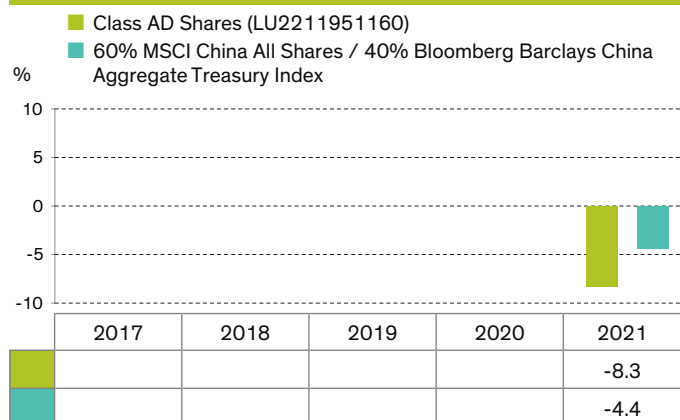
