What is this product?**Type**

This is an open-ended investment fund.

Term

The Portfolio does not have a specific maturity date. The Board may unilaterally decide to liquidate the Portfolio in accordance with the Fund's prospectus.

Investment objective

The Portfolio seeks to increase the value of your investment over time through a combination of income and capital growth (total return) while seeking to moderate volatility

Investment policy

Under normal market conditions, the Portfolio typically invests in equity securities and debt securities of any credit quality (including below Investment Grade debt securities) of companies that are organised, have substantial business activities, or are impacted by developments, in China. These companies may be of any market capitalisation and industry.

The Portfolio may also seek exposure to other asset classes such as commodities, real estate, currencies, interest rates and any other eligible indices. The Portfolio is not limited in its exposure to equity and debt securities.

The Portfolio may utilise all markets where these equity securities are traded, including the China Connect Scheme and the China A-share and H-share equity markets of both China and offshore equity markets. The Portfolio may also invest in China through the QFI Scheme.

The Portfolio may utilise all bond markets where these debt securities are traded including Bond Connect.

The Portfolio may invest in, or be exposed up to 20% in structured products such as asset- and mortgage-backed securities (ABSs/MBs) and 10% in convertible contingent bonds (CoCos).

The Investment Manager uses fundamental research and a proprietary quantitative analysis to flexibly adjust investment exposures across various asset classes with the goal of building an optimal risk/return portfolio in all market conditions.

The Portfolio may be exposed to any currency.

The Portfolio uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes (including to take synthetic short positions).

Terms to understand

Asset-backed securities: Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

Below Investment Grade securities: Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

Bond Connect: A mutual market access scheme that allows investors from mainland China and overseas to trade in each other's respective debt securities markets.

China A-share equity markets: Comprised currently of portions of both Shanghai Stock Exchange and the Shenzhen Stock Exchange. A-shares are shares of mainland China-based companies.

China Connect Scheme: A trading-linked program for Chinese securities developed by, among others, the Hong Kong, Shanghai, and Shenzhen stock exchanges.

China H-share equity markets: Exchanges or markets outside of mainland China where H-shares of Chinese companies are traded.

Contingent convertible bonds ("CoCos"): CoCos are a type of contingent security issued by global financial institutions. CoCos are usually subordinated and convert to the issuer's equity and/or have a write-down following the occurrence of a pre-determined event.

Debt securities: Securities that represent the obligation to pay a debt, with interest.

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Duration: A measure of how much the price of a fixed-income asset will fluctuate as a result of changes in the interest rate environment. Securities with a higher duration are typically more sensitive and can have greater price fluctuations in case of changes in the interest rates.

Equities: Securities that represent an ownership stake in a company.

Investment Grade Securities: Debt securities rated at or above BBB-/ Baa3.

Mortgage-backed securities: Debt securities representing an interest in a pool of mortgages.

Offshore equity markets: Exchanges or markets located in the U.S., Hong Kong, the United Kingdom, Singapore, Korea, and Taiwan.

Other investment purposes: In line with the Portfolio's investment objective and policy, means to gain exposure and/or to manage duration.

Volatility: Measure of the pricing behavior of a security.

Responsible investing

The Portfolio is classified as Article 8 under Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (SFDR). Benchmark

60% MSCI China All Shares, 40% Bloomberg China Aggregate Treasury Index used for performance comparison, risk measurement, and volatility measurement.

Intended retail investor

The Portfolio is intended for investors with a basic knowledge and limited/no experience of investing in funds. This Portfolio is intended for investors seeking to increase the value of their investment over the recommended holding period and understand the risk of losing some or all the capital invested.

The reference currency of the Portfolio is USD.

Share class currency

The reference currency of the share class is USD.

Distribution policy

This share class is a distributing share class. Dividends may include income, realised capital gains and/or be paid out of capital.

Redemption

Shares may be redeemed on any day on which banks in Luxembourg, Hong Kong, Shanghai, and Shenzhen are open for business and the New York Stock Exchange is open for business (each a Business Day). The risk indicator assumes you keep your investment in the Portfolio for 5 years.

This is the recommended holding period for this Portfolio.

You may not be able to sell your shares easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this Portfolio compared to other investment funds. It shows how likely it is that the Portfolio will lose money because of movements in the markets.

The Portfolio is classified as 4 out of 7, which is a medium risk class.

Risks materially relevant to the Portfolio but not adequately captured by the SRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Allocation risk: The Portfolio's allocation to various asset classes may change over time and this could impact the performance of the Portfolio positively or negatively.

China Liquidity risk: The Portfolio invests in China via the QFI scheme which involves liquidity risks as the market is regulated by state-supervised systems, which may take actions outside the Investment Manager's control. The Portfolio may additionally invest in domestic Chinese equity markets through the Shanghai-Hong Kong Stock Connect Scheme, and so is subject to the custody, execution and liquidity risks of investing in securities via this newly established market infrastructure.

China Market risk: The Portfolio will primarily invest in domestic securities of issuers located in China and so will be directly affected by volatility in securities markets in China and changes in the economic and political climate in China generally. The legal and regulatory framework for capital markets in China may not be as well developed as those of developed countries and entails additional risks.

Counterparty risk: If an entity with which the Portfolio does business becomes insolvent, payments owed to the Portfolio could be delayed, reduced and/or eliminated.

Currency risk: In the event of a share class denominated in a different currency than the investor's local currency, the return of the investor will be impacted by the exchange rate between the share class currency and the investor's local currency.

Performance Scenarios

What you will get from this share class depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the share class over the last 10 years. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. For any periods before the share class activation/reactivation, 60% MSCI China All Shares, 40% Bloomberg China Aggregate Treasury Index and a similar share class proxy (if applicable) was used to replicate expected returns.

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest USD 10,000.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other investment funds.

The scenarios presented are an estimate of future performance based on evidence from the past, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment.

The figures shown include all the costs of the share class itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Unfavourable scenario: This type of scenario occurred for an investment between January 2021 and December 2023.

Moderate scenario: This type of scenario occurred for an investment in the benchmark between August 2014 and August 2019.

Favourable scenario: This type of scenario occurred for an investment in the benchmark between February 2016 and February 2021.

What happens if AllianceBernstein (Luxembourg) S.à r.l. is unable to pay out?

The Fund's assets are held with a separate company, the depositary, so the Fund's ability to pay out would not be affected by the insolvency of AllianceBernstein (Luxembourg) S.à r.l.

However, in the event of the depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation scheme in place which may offset, all or part, of this loss.

What are the costs?

Costs over time: The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold your investment in the Portfolio. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the share class performs at the greater of 0 % or as shown in the moderate scenario;
- USD 10,000 is invested.

(*)This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 6.5% before costs and 3.3% after costs.
