OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through capital growth.

Investment policy

Under normal market conditions, the Fund typically invests at least 80%, and not less than two thirds, of its assets in equity securities of companies in health care and health care-related industries. These companies may be of any market capitalization and from any country, including emerging markets.

The Investment Manager seeks to select securities that it believes offer superior long-term growth characteristics.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks) and efficient portfolio management.

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

MSCI World Health Care Index used for performance comparison.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark, however, given the Fund's focus on a narrow sector of the equity market, the Fund's performance or certain other characteristics may, at times and under certain market conditions, have a close resemblance to that of the benchmark. Distribution policy

What does this risk indicator mean?

Why is this Fund in this category?

The Fund is not guaranteed in capital. The Fund is invested in equity securities that can face sharp variations up or down and that can generate significant gains or losses.

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Counterparty risk: If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

Focus risk: The Fund may have significant exposure to a single industry sector or country, and could be more sensitive to events impacting that sector or country.

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.


The entry and exit charges shown are maximum figures. In some cases, you might pay less – you can find this out from your financial advisor.
