# **OBJECTIVES AND INVESTMENT POLICY**

# **Investment objective**

The Fund seeks to increase the value of your investment over time through capital growth.

# Investment policy

Under normal market conditions, the Fund typically invests in equity securities of companies that are organized, have substantial business activities in developed countries as well as emerging markets, that the Investment Manager believes have lower volatility. These companies may be of any market capitalization and industry.

The Investment Manager seeks to select securities that it believes are high quality, have low volatility and reasonable valuations and offer attractive Shareholder returns.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes.

# **Responsible Investing**

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

# Benchmark

MSCI World Index used for performance comparison and volatility measurement.

# What does this risk indicator mean?


