OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through capital growth while seeking to maximize risk-adjusted returns relative to the overall US equity markets.

Investment policy

Under normal market conditions, the Fund typically invests at least 80% of its assets in equity securities. The Fund mainly invests in medium and large-sized companies that are traded in the US.

The Investment Manager seeks to select securities that it believes offer superior investment return characteristics. The Fund may hold securities for a short period of time when implementing the investment strategy and therefore may experience high trading volumes.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and other investment purposes.

Responsible Investing

The Fund is classified as Article 8 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

S&P 500 Index used for performance comparison.

The Fund is actively managed and the Investment Manager is not constrained by its benchmark, however the Fund's performance or certain other characteristics may, at times and under certain market conditions, have a close resemblance to that of the benchmark. Hedged share class

This share class seeks to reduce the effect of exchange rate fluctuations between the Fund's base currency and the currency of the share class.

Fund currency

The reference currency of the Fund is USD.

Share class currency

The reference currency of the share class is AUD.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

Terms to understand

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Equities: Securities that represent an ownership stake in a company.

Other investment purposes: In line with the Fund's investment objective and policy, means to gain exposure.

What does this risk indicator mean?

Why is this Fund in this category?

The Fund is not guaranteed in capital. The Fund is invested in equity securities that can face sharp variations up or down and that can generate significant gains or losses.

Risks materially relevant to the Fund but not adequately captured by the SRRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Counterparty risk: If an entity with which the Fund does business becomes insolvent, payments owed to the Fund could be delayed, reduced, or eliminated.

Focus risk: The Fund may have significant exposure to a single industry sector or country, and could be more sensitive to events impacting that sector or country.

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.
