What is this product?**Type**

This is an open-ended investment fund.

Term

The Portfolio does not have a specific maturity date. The Board may unilaterally decide to liquidate the Portfolio in accordance with the Fund's prospectus.

Investment objective

The Portfolio seeks to increase the value of your investment over time through a combination of income and capital growth (total return).

Investment policy

Under normal market conditions, the Portfolio typically invests in equity and debt securities from issuers anywhere in the world, including emerging market countries. The Portfolio is not limited in its exposure to equities or debt securities but expects higher exposure to equities than to debt securities.

The Portfolio may invest in, or be exposed up to (i) 20% in below Investment Grade debt securities rated above Caa1/CCC+/ CCC and (ii) 20% in structured products such as asset-backed and mortgage-backed securities.

The Investment Manager invests in securities or issuers that it believes are positively exposed to environmentally or socially-oriented sustainable investment themes derived from the UN Sustainable Development Goals (UN SDGs).

The Investment Manager emphasises positive selection criteria, in particular by analysing the exposure to environmental, social and governance (ESG) factors of each security or issuer, over broad-based negative screens in assessing an issuer's exposure to such ESG factors.

The Portfolio may be exposed to any currency.

The Portfolio uses derivatives to a significant extent for hedging (reducing risks), efficient portfolio management and other investment purposes.

Terms to understand

Asset-backed securities: Debt securities representing an interest in a pool of consumer debt, such as credit card debt or automobile loans.

Below Investment Grade Securities: Debt securities rated below Investment Grade that may be higher-yielding but riskier debt securities.

Debt securities: Securities that represent the obligation to pay a debt, with interest.

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Duration: A measure of how much the price of a fixed-income asset will fluctuate as a result of changes in the interest rate environment. Securities with a higher duration are typically more sensitive and can have greater price fluctuations in case of changes in the interest rates.

Emerging market countries: Nations whose economies and securities markets are less established.

Equities: Securities that represent an ownership stake in a company.

Investment Grade Securities: Debt securities rated at or above BBB-/ Baa3.

Mortgage-backed securities: Debt securities representing an interest in a pool of mortgages.

Other investment purposes: In line with the Portfolio's investment objective and policy, means to gain exposure and/or to manage duration.

Sustainable investment themes: Those investment themes that are derived from the UN SDGs such as Health, Climate, and Empowerment and Institutions for sovereign debt. Sustainable investment themes may change over time.

UN Sustainable Development Goals ("UN SDGs"): A set of 17 goals that represent the United Nations' aspirational view of how the world could look like by 2030. The 17 goals address economic prosperity, environmental sustainability and social inclusion.

Responsible investing

The Portfolio is classified as Article 9 under Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (SFDR). Benchmark

Euro Short-Term Rate (ESTER) + 5% used for performance comparison.
60% MSCI World Index (50% USD and 50% EUR hedged) and 40% Bloomberg Global Aggregate Index (EUR hedged) used for risk measurement.
The Portfolio is actively managed and the Investment Manager is not constrained by its benchmarks. Please see the Fund's prospectus for more information.

Intended retail investor

The Portfolio is intended for investors with a basic knowledge and limited/no experience of investing in funds. This Portfolio is intended for investors seeking to increase the value of their investment over the recommended holding period and understand the risk of losing some or all the capital invested.

Portfolio currency

The reference currency of the Portfolio is EUR.

Share class currency

The reference currency of the share class is USD.

Hedged share class: This share class seeks to reduce the effect of exchange rate fluctuations between the Portfolio's base currency and the currency of the share class.

Distribution policy

This share class is a distributing share class. Dividends may include income, realised capital gains and/or be paid out of capital.

Redemption

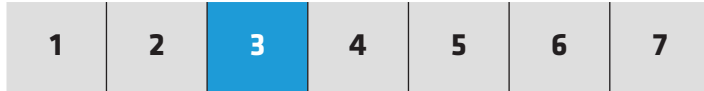

What are the risks and what could I get in return?

The risk indicator assumes you keep your investment in the Portfolio for 5 years.

This is the recommended holding period for this Portfolio.

You may not be able to sell your shares easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator (SRI) is a guide to the level of risk of this Portfolio compared to other investment funds. It shows how likely it is that the Portfolio will lose money because of movements in the markets.

The Portfolio is classified as 3 out of 7, which is a medium-low risk class.

Risks materially relevant to the Portfolio but not adequately captured by the SRI:

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Allocation risk: The Portfolio's allocation to various asset classes may change over time and this could impact the performance of the Portfolio positively or negatively.

Counterparty risk: If an entity with which the Portfolio does business becomes insolvent, payments owed to the Portfolio could be delayed, reduced and/or eliminated.

Currency risk: In the event of a share class denominated in a different currency than the investor's local currency, the return of the investor will be impacted by the exchange rate between the share class currency and the investor's local currency.

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.

Performance Scenarios

What you will get from this share class depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the share class over the last 10 years. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. For any periods before the share class activation/reactivation, the Portfolio's benchmark, which is a reference rate, cannot be used for the purpose of this calculation. 30% MSCI World Index, 30% MSCI World Index (EUR hedged), 40% Bloomberg Global Aggregate Index (EUR hedged) and a similar share class proxy (if applicable) was used to replicate expected returns.

This table shows the money you could get back over the next 5 years, under different scenarios, assuming that you invest USD 10,000.

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other investment funds.

The scenarios presented are an estimate of future performance based on evidence from the past, and are not an exact indicator. What you get will vary depending on how the market performs and how long you keep the investment.

The figures shown include all the costs of the share class itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Unfavourable scenario: This type of scenario occurred for an investment between December 2021 and December 2023.

Moderate scenario: This type of scenario occurred for an investment in the benchmark between November 2015 and November 2020.

Favourable scenario: This type of scenario occurred for an investment in the benchmark between October 2016 and October 2021.

What happens if AllianceBernstein (Luxembourg) S.à r.l. is unable to pay out?

The Fund's assets are held with a separate company, the depositary, so the Fund's ability to pay out would not be affected by the insolvency of AllianceBernstein (Luxembourg) S.à r.l.

However, in the event of the depositary's insolvency, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the depositary is required by law to segregate its own assets from the assets of the Fund. There is no investor compensation scheme in place which may offset, all or part, of this loss.

What are the costs?

Costs over time: The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold your investment in the Portfolio. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the share class performs at the greater of 0 % or as shown in the moderate scenario;
- USD 10,000 is invested.

(*)This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 7.9% before costs and 4.8% after costs.
