OBJECTIVES AND INVESTMENT POLICY

Investment objective

The Fund seeks to increase the value of your investment over time through capital growth through sustainable investments.

Investment policy

Under normal market conditions, the Fund typically invests at least 80% of its assets in equity securities of issuers that the Investment Manager believes sell and/or offer climate solutions. Climate solutions are products or services that seek to address environmental challenges relating to climate change such as clean energy, transportation, recycling, resource efficiency and water. These companies may be of any market capitalization and from any country, including emerging markets.

The Investment Manager invests in securities that it believes are positively exposed to sustainable climate solutions derived from the UN Sustainable Development Goals (UNSDGs).

The Investment Manager emphasizes positive selection criteria, in particular by analyzing the exposure to environmental, social and governance (ESG) factors of each security or issuer, over broad-based negative screens in assessing an issuer's exposure to such ESG factors.

For China-A Shares, the Fund may invest in all markets on which these Shares are traded, such as China Connect Scheme markets. The Fund may also invest in equities of Chinese companies traded in Hong Kong or other offshore markets. The Fund may also invest in China through a Renminbi Qualified Foreign Institutional Investor (RQFII) and Qualified Foreign Institutional Investor (QFII) programs, that may be held by the Management Company or an affiliate.

The Fund may be exposed to any currency.

The Fund uses derivatives for hedging (reducing risks), efficient portfolio management and for investment purposes.

Responsible Investing

The Fund is classified as Article 9 under SFDR. For more information, please refer to sustainability-related disclosures in the prospectus.

Benchmark

MSCI All Country World Index used for performance comparison.

The reference currency of the share class is EUR.

Distribution policy

This share class is a non-distributing share class. Income and capital gains derived from the Fund are reinvested.

Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

Terms to understand

China A-Shares: Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai Stock Exchange and the Shenzhen Stock Exchange. A-shares are generally available for purchase by mainland citizens in China; foreign investment in A-shares is subject to significant regulatory restrictions.

China Connect Scheme: A trading-linked program for Chinese securities developed by, among others, the Hong Kong, Shanghai, and Shenzhen stock exchanges.

Derivatives: Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Duration: A measure of how much the price of a fixed-income asset will fluctuate as a result of changes in the interest rate environment. Securities with a higher duration are typically more sensitive and can have greater price fluctuations in case of changes in the interest rates.

Emerging market countries: Nations whose economies and securities markets are less established.

Equities: Securities that represent an ownership stake in a company.

Other investment purposes: In line with the Fund's investment objective and policy, means to gain exposure and/or to manage duration.

SFDR: Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector.

Sustainable climate solutions: Products and services that seek to address environmental challenges relating to climate change. Sustainable climate solutions may change over time.

UN Sustainable Development Goals ("UNSDGs"): A set of 17 goals that represent the United Nations' aspirational view of how the world could look like by 2030. The 17 goals address economic prosperity, environmental sustainability and social inclusion.

What does this risk indicator mean?

Why is this Fund in this category?

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events, which could amplify everyday risks and could trigger other risks, such as:

Liquidity risk: Certain securities could become hard to buy or to sell at a desired time or price.

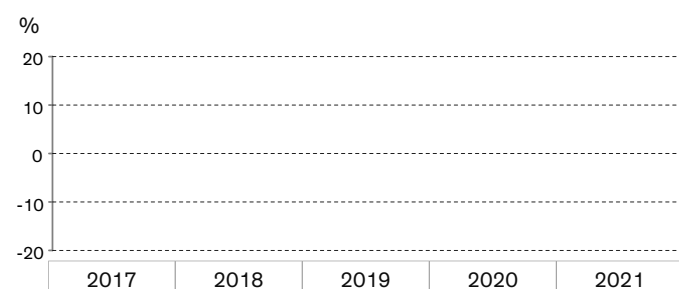
The entry and exit charges shown are maximum figures. In some cases, you might pay less – you can find this out from your financial advisor.
