# **Investment Policy**

Portfolio Securities - The Fund invests directly or indirectly (including through QFI, the Shanghai-Hong Kong Stock Connect programme, participatory notes, equity linked notes and any other eligible means) at least two thirds in shares of companies whose securities are listed on Chinese Stock Suchasses including without limitation. A-Shares and B-Shares of Exchanges, including, without limitation, A-Shares and B-Shares of companies listed on the Shanghai and Shenzhen Stock Exchanges or other equivalent securities authorised by the China Securities Regulatory Commission for purchase by non-Chinese investors.

# **Management Process**

- The Fund is actively managed.

- The benchmark is used as a reference point for portfolio construction and as a basis for setting risk constraints.

- In order to achieve its objective, the Fund will take positions whose weightings diverge from the benchmark or invest in securities which are not included in the benchmark. The investments of the Fund may deviate significantly from the components and their weightings in the benchmark.


