This Fund is managed by ABN AMRO Investment Solutions, an investment management company of the ABN Amro Group.

Objectives and Investment Policy

Profile 6 belongs to the category of Profile Funds.

The Fund seeks to increase the value of its assets over the long term by implementing a very high risk allocation strategy on various asset classes, either directly or indirectly (in derivatives on this type of asset and through Funds). Emphasis is placed on international diversification of investments.

The Fund will implement a tactical allocation around the following strategic allocation:

- Equities: 90%
- Bonds: 0%
- Short-term debt securities: 10%

The Fund may on top be exposed to commodities and gold markets, with a maximum exposure of 10%, through undertakings for collective investment, such as ETFs and ETCs.

Moreover, the minimum ownership in equity securities will be of 51% of the Fund's net assets.

The Fund may also use derivatives on this type of asset for investment and hedging purposes.

After hedging, the exposure to currencies other than the euro may be minimised.

This Fund is actively managed and is compared to the 90% * (50% MSCI Europe TR Net + 40% MSCI World ex Europe TR Net + 10% MSCI EM TR Net) + 10% Euribor 1 month Capitalized for performance and risk level indicator purposes. However, the reference to this index does not constitute any objective or limitation in the management and composition of the portfolio and the Fund does not restrain its universe to the index components.

Therefore returns may deviate materially from the performance of the reference index.

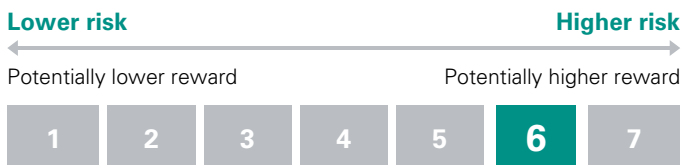
The base currency of the Fund is EUR.

The minimum recommended holding term is 5 years.

Income is systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

Risk and Reward Profile



The Risk and Reward profile of the Fund is based on the variations in value that an investment in this Fund has experienced. The classification of the Fund is a reasonably accurate reflection of the risk of the Fund over past market conditions. Historical data used in determining the profile is not a reliable indication for the risk inherent in any future circumstances and events that differ from what the Fund has undergone in the past.

The Risk and Reward profile of a Fund is an indicator but not a target or a guarantee and may shift over time.

The lowest risk category does not mean that the Fund is free of risk. Higher possible returns generally also imply higher possible risks.

Why is the Fund in this specific category?

The risk level of this Fund is generally determined by its asset allocation, the investment markets and economic sectors, as well as the currency exposure.

The risk level of the Fund mainly reflects the risk arising from investment in equities, bonds, money market and derivatives instruments of this type of asset.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

Country-Specific Risk: Investments in some countries (China, India, Indonesia, Japan, Saudi Arabia, and Thailand) involve risks linked to restrictions imposed on foreign investors and counterparties, higher market volatility and the risk of lack of liquidity for some lines of the

portfolio. In addition, the repatriation by foreign investors of their share of net profits, capital and dividends may be restricted or require the approval of the government. The Company will only invest if it considers that the restrictions are acceptable. However, no guarantee can be given that additional restrictions will not be imposed in future.

Emerging Market Risk: Investing in emerging markets is likely to be subject to a higher than average volatility. In addition, some emerging markets offer less security than the majority of international developed markets. For this reason, services for portfolio transactions, liquidation and conservation on behalf of Funds invested in emerging markets may carry greater risk.

Small Cap, Specialised or Restricted Sectors Risk: Investing in small caps or specialised or restricted sectors is likely to be subject to a higher than average volatility. Smaller companies may find themselves unable to generate new funds to support their growth and development, they may lack vision in management, or they may develop products for new, uncertain markets.

Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the Fund on such markets could be more risky.

Gold and commodities Market Risks: Commodities markets may experience significant, sudden price variations that have a direct effect on the valuation of shares and securities that equate to the shares in which a sub-fund may invest and/or indices that a sub-fund may be exposed to. Moreover, the underlying assets may evolve in a markedly different way from traditional securities markets (equity markets, bond markets, etc...).

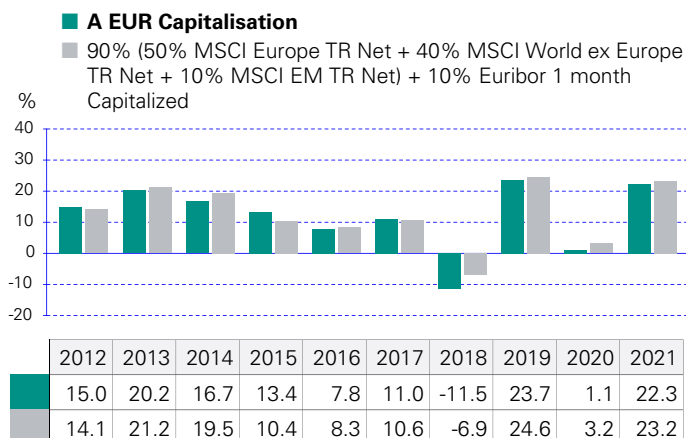
