Emerging Markets Sustainable and Responsible Investment Equity Fund, a US Dollar denominated sub fund of the Aberdeen Standard SICAV I, A Acc USD Shares (ISIN: LU1581387781). This fund is managed by Aberdeen Standard Investment Luxembourg S.A.

OBJECTIVES AND INVESTMENT POLICY

Investment Objective

The Fund aims to achieve a combination of growth and income by investing in companies identified by the Investment Manager's "Sustainable and Responsible" investment process and are based in Emerging Markets countries.

The Fund aims to outperform the MSCI Emerging Markets Index (USD) benchmark before charges.

Investment Policy

Portfolio Securities

- The Fund invests at least two-thirds in equities and equity related securities of companies based, or carrying out most of their business in Emerging Market countries.

- The Fund will exclude investment in companies that do not comply with any of the 10 Principles of the United Nations Global Compact, in tobacco manufacturers, thermal coal producers, and in companies having direct involvement in the development and production of controversial weapons.

- Furthermore, the Fund will exclude investment in companies which derive more than 10% of their turnover from gambling, the manufacture or sale of conventional weapons or weapons systems, or which appear on the Norges Bank Investment Management (NBIM) exclusion list.

- The Fund may invest up to 30% of its net assets in Mainland China equity and equity-related securities, including through available QFII and RQFII quotas, the Shanghai-Hong Kong and Shenzhen-Hong Kong Stock Connect programme or by any other available means.

Management Process

- The Fund is actively managed.

- The investment team's "Sustainable and Responsible" investment process assigns ratings to industry sectors and individual companies. A company with a lower than average rating in a medium or high risk sector will be excluded from the investment universe. Details on the investment approach will be published at www.aberdeenstandard.com.

- The benchmark is used as a reference point for portfolio construction and as a basis for setting risk constraints.

- In order to achieve its objective, the Fund will take positions whose weightings diverge from the benchmark or invest in securities which are not included in the benchmark. The investments of the Fund may deviate significantly from the components and their weightings in the benchmark.

- Due to the active nature of the management process, the Fund's performance profile may deviate significantly from that of the benchmark over the longer term.

Derivatives and Techniques

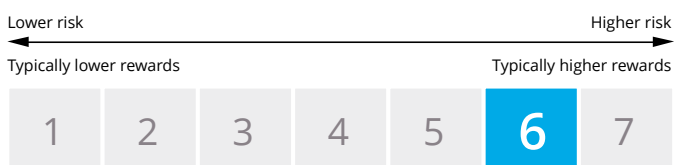
- The Fund may utilise financial derivative instruments for hedging and/or investment purposes, or to manage foreign exchange risks. The use of derivatives for investment purposes is expected to be very limited, mainly in those cases where there are significant inflows into the Fund so that cash can be invested while the investment in equity and equity related securities is maintained.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

Recommendation: the fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The fund is rated as 6 because of the extent to which the following risk factors apply:

- Investing in China A shares involves special considerations and risks, including greater price volatility, a less developed regulatory and legal framework, exchange rate risk/controls, settlement, tax, quota, liquidity and regulatory risks.
- The use of derivatives carries the risk of reduced liquidity, substantial loss and increased volatility in adverse market conditions, such as a failure amongst market participants. 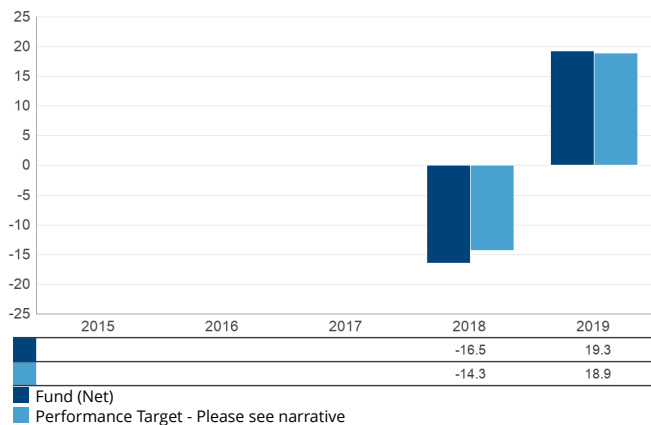
