Key information document

What is this product?

Type: Shares of AMUNDI WELT ERTRAG NACHHALTIG, an undertaking for collective investment in transferable securities (UCITS), established as an investment fund.

This is a UCITS investment fund established in Germany. The AMUNDI WELT ERTRAG NACHHALTIG investment fund is a collective investment undertaking which collects capital from a number of investors in order to invest it in accordance with a defined investment strategy for the benefit of these investors.

Term: The term of the Fund is open-ended. The Management Company may terminate the Fund by dissolution or merger with another fund, in accordance with the legal provisions.

Objectives: The Fund is classified in accordance with Article 8 of the Disclosure Regulation, i.e. it pursues an investment policy aligned with ESG criteria.

The aim of the Fund Management is to achieve long-term capital growth by means of a sustainable and growth-oriented investment policy.

To achieve this objective, a total of at least 30%, but not more than 70%, of the value of the Fund's assets are invested in equities. At least 51% of its value is invested in securities, money market instruments and other investment instruments whose issuers are considered sustainable. Issuers are assessed as sustainable based on environmental criteria, social considerations and the type of corporate governance. A separate ESG scoring methodology is used for this purpose. The assessment process results in an overall assessment: the ESG rating. The ESG rating is a weighted average of the scores for the ESG areas, ranging from A to G, where A is the highest and G is the lowest. Issuers with an ESG rating of A to D are defined as sustainable.

The investment strategy, which is geared toward sustainability, is also

complemented by the application of a targeted exclusion policy. The Fund may use derivative transactions for hedging, speculative purposes and for efficient portfolio management. In addition, the Fund may invest in accordance with the "General and Special Conditions of

The Fund does not track a securities index, nor does the company base itself on a fixed benchmark for the Fund. At its own discretion, the Fund Management actively decides on the selection of assets, taking into account analyses and valuations of financial instruments as well as economic and political developments. It aims to achieve positive performance.

Intended retail investors: This product is intended for investors with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment and to receive income over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and dealing: Shares may be sold (redeemed) as stated in the prospectus and investor information document at the respective dealing price (net asset value), subject to suspension of redemption by the Management Company owing to extraordinary circumstances. Distribution policy: The Fund income remains in the Fund and increases the value of the shares.

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products.
