Arabesque SICAV - Global ESG Momentum Flexible Allocation (the "Sub-Fund") is a Sub-Fund of Arabesque SICAV (the "Fund")

Class SEK (the "Class") - ISIN: LU1653149309

The Fund has appointed FundPartner Solutions (Europe) S.A. as Management Company.

Objectives and investment policy

The objective of Arabesque SICAV - Global ESG Momentum Flexible Allocation (the "Sub-Fund") is long-term capital appreciation through investments into a sustainable equity universe (Arabesque Investment Universe) and cash instruments. The Arabesque Investment Universe is determined on a quarterly basis.

The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

The Sub-Fund promotes certain environmental and social characteristics within the meaning of article 8 of SFDR but does not have a sustainable investment objective.

The Fund Manager integrates sustainability risks and opportunities into its research, analysis and investment decision-making processes. The Sub-Fund is managed to promote, among other characteristics, a combination of environmental and social characteristics (as provided under article 8 of SFDR), but does not have as its objective sustainable investments.

As a general rule, past results offer no guarantee of future performance. There can be no guarantee that the Sub-Fund's objectives will be achieved.

The Arabesque Investment Universe contains equities and equity-related securities from companies worldwide that have passed a systematic selection process. The ESG assessment utilizes a Best in Class approach per sector to exclude companies with inferior scores. Companies that are in breach of the principles of UN Global Compact (human rights, labour rights, anti-corruption, environment) are excluded as well. The Arabesque Investment Universe is furthermore screened by liquidity parameters such as market capitalization, daily turnover and free float.

The Sub-Fund will seek to be mainly invested in:

- equities and equity related securities (such as, but not limited to, ordinary or preferred shares, rights, certificates, ADR, GDR, notes) issued by companies worldwide that are contained in the Arabesque Investment Universe; and/or
- cash and cash equivalents (money market instrument, money market undertakings for collective investment).

Depending on market conditions and the Fund Manager's conviction, it is

understood that investments in equities and equity related securities may vary between 0% and 100% of the net assets of the Sub-Fund. It is indeed possible that under exceptional market conditions and for a limited amount of time the allocation to cash and cash equivalents represents more than 49% of the net assets.

The choice of investments will neither be limited by geographical area (including emerging markets), by economic sector nor in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country and/or in a single economic sector and/or in a single currency.

Under normal market conditions, the maximum position size of any single stock should be 1% of the market value of the Sub-Fund's net assets, without being a constraint.

The Sub-Fund's investments in units or shares of UCIs shall not exceed 10% of its net assets.

Dealing Frequency

The net asset value for this Class is calculated on each business day in Luxembourg ("Calculation Day") based on the pricing of the preceding full business day ("Valuation Day"). The cut-off time to submit subscription and/or redemption orders is 2 p.m. Luxembourg time on the full bank business day in Luxembourg preceding the relevant Calculation Day.

Distribution Policy

The income on all classes of the Sub-Fund may be distributed.

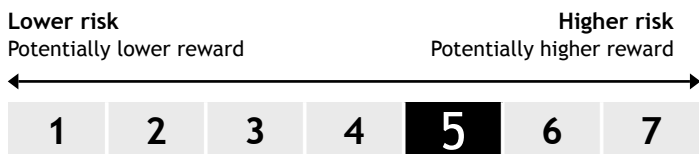
Currency

Why is this Sub-Fund in this category?

The investment objective of the Sub-Fund is to generate long-term capital appreciation through investments into a sustainable equity universe (Arabesque Investment Universe) and cash instruments. Asset allocation and stock selection are determined by a quantitative approach. The Arabesque Investment Universe is determined on a quarterly basis. The Sub-Fund will present a risk/reward profile corresponding to a Medium High risk category on the risk/reward scale.

Are there any other particular Risks?

Risks that could affect Sub-Fund performance and are not necessarily fully reflected in the risk and reward rating include:

- **Liquidity risks:** The Sub-Fund may be exposed to less liquid securities. Those are securities that cannot easily be sold or exchanged for cash without a substantial loss in value in certain market conditions. Those securities also cannot be sold quickly because of a lack of ready and willing investors or speculators to purchase the asset.
- **Counterparty risks:** The Sub-Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Sub-Fund.
- **Credit risks:** The Sub-Fund may not invest in debt securities.
- **Risks from the use of derivatives:** The Sub-Fund may not use financial derivative instruments.
- **Operational risks:** The Sub-Fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the Management Company or by external third parties or may be damaged by external events, such as natural disasters.
- **Sustainability risk:** This risk is any environmental social or governance event or condition that could impact the value of investments. The Investment Manager primarily relies on its ESG analysis and climate risk indicators to categorise the potential level of Sustainability risks in each fund. The level of sustainability risk may fluctuate depending on which investment opportunities the Investment Manager identifies. This means that the fund is exposed to Sustainability Risk which may impact the value of investments over the long term.

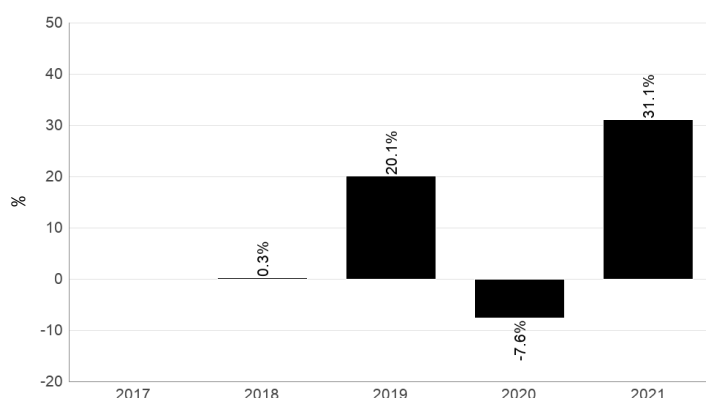
The percentage of ongoing charges is based on the last year's expenses, ending 31/12/2021. This figure may vary from year to year. It excludes:
