What is this product?

Type: This product is a sub-fund of Aristea SICAV, an open ended investment company with variable capital and an umbrella fund with segregated liability between the sub-funds, established under the laws of Luxembourg and authorised by Commission de Surveillance du Secteur Financier as a UCITS for the purposes of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment, as may be amended from time to time.

Intended Retail Investor: Suitable for investors with a short-term time horizon, typically three years or less.

Term: This Fund has no maturity date.

Objectives:

We aim to provide you with returns exceeding those of interest rates on deposits having a maturity of 1 year or less ("money markets").

We mainly invest in deposits with European (EU) credit institutions that are repayable on demand. We invest in deposits with credit institutions that may be riskier than those qualifying as "high quality eligible assets" under the aforementioned Regulation. We may also invest in bonds (loans) issued by companies or public issuers, which are repayable in less than 18 months, and in units of investment Funds. We may invest in complex financial instruments which may have a significant influence on the return of the Fund. Our investment decisions are based on a thorough analysis of the creditworthiness of credit institutions over the contemplated deposit period. We also take into account the level of interest paid on deposits with these credit institutions.

In accordance with article 6 of EU regulation 2019/2088, the subfund does not promote environmental or social characteristics nor has as objective sustainable investment, as further disclosed in the Prospectus. This Fund does not either take into account the EU Taxonomy criteria for environmentally sustainable economic activities.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 2 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than your original investment. In addition to the market price risk, please refer to the Fund's Prospectus for further information.

If the Fund currency differs from your investment currency, you will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level. Poor market conditions could impact your returns.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The figures shown include all the costs of the product itself, but do not take into account your personal tax situation and may not include all the costs that you pay to your advisor or distributor, which may also affect how much you get back.

What happens if the Company is unable to pay out?

The assets of the Fund are entrusted to the Depositary. If the Fund encounters financial difficulties, the assets entrusted to the Depositary (or its delegates) will not be affected. If the Depositary (or its delegates) encounter financial difficulties, the Fund could suffer a loss in some circumstances.

What are the costs?

Costs over Time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for two different holding periods. The figures assume you invest EUR 10,000. The figures are estimates and may change in the future. The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs and show you the impact that all costs will have on your investment over time.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs.
