Objective and Investment Policy

Investment Objective

The Sub-Fund seeks to achieve high attractive income and secondarily capital growth by investing primarily in high yield debt securities denominated in a European currency over a medium-term period.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in high yield European currency debt markets. The following investment decisions are undertaken after comprehensive macroeconomic and microeconomic analysis of the market:

- issuer selection
- sector allocation
- credit curve positioning (the credit curve illustrates the relationship between the investment term and the credit yield)

The Sub-Fund invests primarily in high yield bonds denominated in a European currency and with an expected life term or redemption less than 3 years on the basis of the asset manager's expectations. Such high return bonds have a rating lower than BBB- according to Standard & Poor's (or equivalent rating by Moody's or other rating agencies) or are not rated.

The Sub-Fund may also invest in Investment Grade debt securities denominated in a European currency issued by foreign corporations or governments or governmental agencies or instrumentalities.

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through

derivatives, in particular by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.

The Unit Class aims at hedging the foreign exchange risk resulting from the divergence between the reference currency of the Sub-Fund and the currency of this Unit Class by using derivatives instruments whilst retaining the exposure to Investment Policy described above.

Sub-Fund Currency

The reference currency of the Sub-Fund is Euro.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 3 years.

Processing of subscription and redemption orders

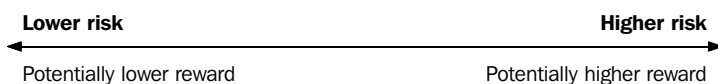
The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 10 a.m. CET. Orders will be processed at the Net Asset Value calculated the next business day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.

Minimum initial investment: 10,000 in the relevant reference currency of the relevant Unit class.

Minimum subsequent investment: 5,000 in the relevant reference currency of the relevant Unit class.

Why is this Sub-Fund in this category?

Additional Risks

Impact of any techniques such as derivatives: certain management strategies involve specific risks, such as liquidity risk, credit risk, counterparty risk, legal risk, valuation risk, operational risk and risks related to the underlying assets.

The use of such strategies may also involve leverage, which may increase the effect of market movements on the Sub-Fund and may result in significant risk of losses.

Charges

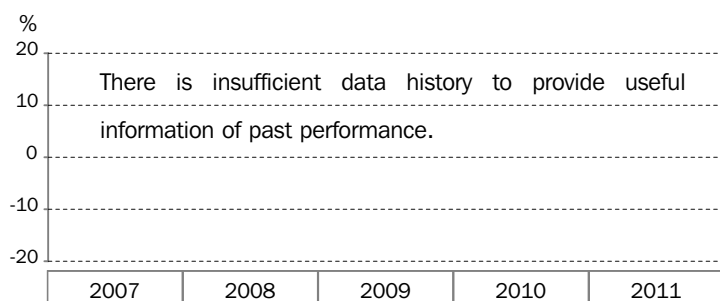
