Objective and Investment Policy

Investment Objective

The Sub-Fund seeks to achieve long-term capital growth measured in USD by investing mainly in equities issued companies domiciled or operating predominantly in emerging markets.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in emerging market equities worldwide. Investment decisions are based on a combination of macroeconomic, sector and company specific analysis.

The share selection process relies on a rigorous analysis of the companies' business model, quality of management, growth prospects and overall risk return profile.

Emerging market countries cover countries generally considered low or middle income countries by the World Bank and countries included in any recognised emerging market index.

The Sub-Fund invests:

- at least two thirds of its total assets in equities and equities related instruments issued by companies domiciled or operating predominantly in the emerging market countries
- up to 10% of its assets in convertible or straight bonds and not more than one third in money market instruments

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.

Sub-Fund Currency

The reference currency of the Sub-Fund is USD.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 8 years.

Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. CET. Orders will be processed at the Net Asset Value calculated the second business day thereafter. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.

Minimum initial investment: 500,000 euros or the equivalent in the relevant currency of the relevant Share class.

Minimum subsequent investment: 10,000 euros or the equivalent in the relevant currency of the relevant Share class.

Why is this Sub-Fund in this category?

The capital of the Sub-Fund is not guaranteed. The Sub-Fund is invested in financial markets and uses techniques and instruments which may be subject to sudden and significant variation, which may result in substantial gains or losses.

Additional Risks

Investments may be affected by movements of foreign exchange rates, changes in laws or restrictions applicable to such investments, changes in exchange control regulations or price volatility.




