The fund is a German based UCITS (Undertakings for Collective Investment in Transferable Securities). The management company is DWS Investment GmbH (the manufacturer), a member of DWS Group. What is this product?

Type

The product is a UCITS - Special property in accordance with German authorization.

Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The Company may, however, terminate its right to manage the fund by giving a minimum of six months' notice by way of an announcement in the Bundesanzeiger and additionally in the annual report or semiannual report. Barmenia Renditefonds DWS was launched in 1987.

Objectives

The fund is actively managed. The fund is managed in reference to a benchmark. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. The objective of the investment policy is to generate a return in euro, based on the performance of the benchmark (iBoxx Euro Overall (RI)). In order to achieve this, the fund invests in interest-bearing securities, equities, funds, certificates, warrant-linked bonds, convertible bonds, dividend-right certificates (Genussscheine) and warrants. The fund is managed using sustainability criteria. The securities selected for investment must in particular conform to defined ethical and social criteria. Companies, as issuers, are assessed on the basis of their products and services as well as their business ethics and business practices. For state issuers, the political situation, social relations, as well as labor rights and human rights are taken into consideration. At least 51% of net assets may be invested in interestbearing securities, warrant-linked bonds, convertible bonds, dividend-right certificates (Genussscheine) and index certificates on bond indices, and in warrants that entitle the holder to acquire such securities. Up to 25% of the fund's assets may be invested in equities. More than 35% of the fund's assets may be invested in government bonds issued by the Federal Republic of Germany, the French Republic and the Italian Republic. The securities are to be selected according to their potential for earning the highest possible and most consistent longterm income by taking advantage of the respective market situation. The selection of individual investments is at the discretion of the fund management. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The majority of the fund's securities or their issuers are expected to be components of the benchmark. The fund management will use its discretion to invest in e.g. securities, sectors, ratings that are not included in the benchmark in order to take advantage of specific investment opportunities. It is expected that the portfolio will have a similar weighting to the benchmark. The positioning of the fund can deviate from the benchmark to a limited extent (e.g., by holding positions that are not contained in the benchmark, as well as by an underweighting or overweighting). The actual leeway in this respect is normally relatively low. Despite the fact that the fund aims to outperform the benchmark, the potential outperformance might be limited depending on the prevailing market environment (e.g. less volatile market environment) and actual positioning versus the benchmark. The fund distributes annually. The depositary is State Street Bank International GmbH, Germany. Intended retail investor

The fund is intended for medium term retail investors with basic knowledge/experience, who can bear losses. The fund can be used for general capital accumulation purposes.

What are the risks and what could I get in return?

What happens if DWS Investment GmbH is unable to pay out?

The assets of the fund are kept separately from the own assets of the management company DWS Investment GmbH. Investors of the fund cannot suffer any financial loss as a result of this separation due to a failure of the management company. In the event of a default by the depositary State Street Bank International GmbH, Germany, investors of the fund may suffer a financial loss if their deposits are not covered by the Deposit Guarantee Fund of the Bundesverband deutscher Banken e.V.. If deposits on the fund are made with other credit institutions, investors may also suffer a financial loss, provided that such deposits are not covered by any existing deposit guarantee schemes. The protection of deposits of the fund may also be limited in the case of existing deposit guarantee schemes, as they regularly have restrictions on the coverage of deposits in accordance with their statutes.

What are the costs?

Costs over time

How long should I hold it and can I take money out early?

Recommended holding period: 3 years. The product has no minimum holding period.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
