BlackRock Global Target Return: Growth Fund (the "Fund"), Class A Accu USD (the "Share Class"), ISIN: IE00BMDQ5819, is authorised in Ireland and manufactured by BlackRock Asset Management Ireland Limited (the "Manager") which is part of the BlackRock, Inc group.

The Manager is authorised in Ireland and regulated by the Central Bank of Ireland (the "CBI") and the CBI is responsible for supervising the Manager in relation to this Key Information Document.

**Type:** The Fund is a sub-fund of BlackRock Funds I ICAV, an Irish collective asset-management vehicle constituted as an umbrella fund in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

**Term:** The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

# Objectives

- The Fund aims to provide a return on your investment through a combination of capital growth and income, whilst maintaining a growth risk profile (i.e. an evaluation of risks associated with the portfolio).
- The risk profile of the Fund's portfolio is expected to be 8-12% and is measured, for this purpose, is measured as the volatility (i.e. the degree of fluctuation) of the Fund's returns converted into an annual rate, over a five year period.
- The Fund has a flexible approach to asset allocation and will seek to gain exposure across a variety of asset classes investing globally in
  equity securities (e.g. shares), equity-related securities, fixed income (FI) securities (e.g. bonds), FI-related securities, money market
  instruments (MMIs) (e.g. debt instruments with short-term maturities), deposits, cash and other funds. The FI securities and MMIs may be
  issued by governments, government agencies, companies and supranationals globally and may include investments with a relatively low
  credit rating or which are unrated. The IM seeks to identify investment opportunities across a global investment universe according to the
  macroeconomic categories of 'growth', 'inflation', 'policy' and 'pricing' as described in the prospectus.
- The Fund will seek to stay within the stated risk profile by varying its asset allocations (i.e. mix of asset classes) in different market conditions. The Fund's risk profile may fall outside the stated range from time to time.
- The IM may use financial derivative instruments (FDIs) (i.e. investments the prices of which are based on one or more underlying assets) to help achieve the Fund's investment objective and may thereby generate market leverage (i.e. market exposure in excess of the value of its assets). A significant proportion of the Fund's portfolio may consist of FDIs on a daily basis.
- The Fund is actively managed. The IM has discretion to select the Fund's investments.
- The price of a derivative changes on a daily basis depending on the value of the underlying reference asset(s) which in turn may affect the value of your investment. A change in the value of underlying reference assets can have a greater impact on the value of derivatives than if the assets were held directly since derivatives can be more sensitive to changes in the value of underlying reference assets.
- The Fund invests in fixed income securities, equity securities and collective investment schemes and so the value of your investment may be affected by the factors which impact the value of those asset classes.
- Volatility management will have a direct impact on the Fund's returns. Volatility is the measure of fluctuations of the returns of a given investment. Generally, the higher the volatility, the riskier the investment.
- The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs?" below).
- The relationship between the return on your investment, how it is impacted and the period for which you hold your investment is considered below (see "How long should I hold it and can I take my money out early?").
- The depositary of the Fund is J.P. Morgan SE Dublin Branch.
