You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide capital growth in excess of the ICE BofA 3 Month US Treasury Bill Index + 2.5% before fees have been deducted* over a 3 to 5 year period by investing in bonds worldwide. The fund will invest in bonds issued by governments and companies worldwide, including emerging market countries, which help to advance the United Nations Sustainable Development Goal of taking action to combat climate change and which the investment manager deems to be sustainable investments. *For the target return after fees for each share class please visit the Schroder webpage https://www.schroders.com/en/lu/private-investor/ investing-withus/historical-ongoing-charges/.

The fund is actively managed and invests its assets in (i) sustainable investments, which are investments that are expected to contribute towards combating climate change; and (ii) investments that the investment manager deems to be neutral under its sustainability criteria.

The fund invests at least two-thirds of its assets in bonds denominated in various currencies and issued by governments, government agencies, supra-nationals and companies worldwide, including emerging market countries. The fund will increase its exposure to emerging markets over time. At the fund's launch, the exposure to emerging markets will be at least of 50% of its net assets and this exposure will increase progressively with the intention to reach at least 67% of its net assets after three years. The fund may invest up to 50% of its assets in bonds that have a below investment grade credit rating (as measured by Standard & Poor's or any equivalent grade of other credit rating agencies for rated bonds and implied Schroders ratings for non-rated bonds).

The fund may invest in mainland China through the Qualified Foreign Investor ("QFI") scheme or regulated markets (including the Chinese Interbank Bond Market (CIBM) via Bond Connect or CIBM Direct)

The fund may also invest up to one third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash.

The fund does not directly invest in certain activities, industries or groups of issuers above the limits listed under "Sustainability-Related Disclosure" on the fund's webpage, https://www.schroders.com/en/lu/privateinvestor/qfc

The fund invests in companies that do not cause significant environmental or social harm and have good governance practices, as determined by the investment manager's rating criteria

The investment manager may also engage with companies held by the fund to challenge identified areas of weakness on sustainability issues. The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets

Benchmark: The fund's performance should be assessed against its target benchmark, being to provide capital growth in excess of the ICE BofA 3 Month US Treasury Bill Index + 2.5% over a 3 to 5 year period. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.


Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?
