## Objectives and Investment Policy

The Fund is an index-tracking passively managed fund.

The Fund seeks to replicate (with a maximum tracking error\* of 1%) the performance of the FTSE EPRA Nareit Developed Europe (NTR) (Bloomberg: NEPRA Index) (Hedged to EUR) (the «Index»), by investing in shares issued by companies included in the Index, respecting the Index's weightings (full replication).


\*The tracking error is a risk indicator that measures how closely a fund tracks the performance of its reference index.

A dividend may be distributed on a quarterly basis.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

This share class aims at hedging its currency exchange risk against the Fund's portfolio exposure currency. However, the currency exchange risk cannot be completely neutralized as the hedging technique is based of the Fund's NAV.


