Objectives and Investment Policy


The Fund belongs to the category of money market funds. It seeks to maintain the value of its assets by investing in USD-denominated, high quality money market instruments with a maximum final legal maturity of 2 years. The Fund is not a guaranteed product. There is no currency exposure, other than to the USD.

It is actively managed against the Cash Index USD LIBID 3 Months (RI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)
