Objectives

Investment objective The company CB–ACCENT LUX offers easy access to the different financial markets, while providing risk diversification.

Investment policies CB–ACCENT LUX – Swiss Equity Fund investit dans des actions de sociétés suisses. Le compartiment investit deux tiers au moins de ses actifs nets en actions. Il sélectionne les sociétés dans lesquelles il investit dans une optique à moyen ou long terme et en privilégiant une analyse fondamentale. Il peut aussi investir jusqu'à 30% dans d'autres placements collectifs.

Le compartiment peut aussi détenir des liquidités et utilise des instruments financiers dérivés tant pour la couverture des risques que dans un but d'efficacité de la gestion.

Comme tout investissement en valeurs mobilières, ce compartiment est sujet à des fluctuations. La valeur nette d'inventaire par part peut donc varier à la hausse comme à la baisse en fonction de l'évolution des marchés.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of ADEPA Asset Management S.A. to pay you.

Performance scenarios

What happens if CB-Accent Lux is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 CHF is invested.
