

Key Investor Information

DECALIA - CIRCULAR ECONOMY (the "Sub-Fund") is a sub-fund of DECALIA SICAV (the "Fund") Class I CHF H P (the "Class") - ISIN: LU1787061362 The Fund has appointed FundPartner Solutions (Europe) S.A. as management company.

Objectives and investment policy

The Sub-Fund's investment objective is to seek an attractive long-term capital growth, measured in US dollars (USD), by investing in equities that will structurally benefit from the shift from a linear to a circular economy and that have, to the opinion of the investment manager, a positive impact on the environment thanks to their circular business model.

A circular economy is an alternative to keep products, components and materials at their highest utility and value and considers the reuse and recycling principles.

The Sub-Fund is actively managed. The benchmark index of the Sub-Fund is the MSCI World in USD. It is used for the calculation of the performance fee (payable to the investment manager) and for performance comparison purposes. The Sub-Fund does not track the index and can deviate significantly or entirely from the index.

The Sub-Fund will invest at least two-thirds of its net assets in worldwide equities and equity related securities (including but not limited to Real Estate Investment Trusts (REITs), depository receipts) of companies that have adopted a circular business model.

The choice of investments will neither be limited by geographical area (except a maximum of 30% of the Sub-Fund's net assets in emerging countries), economic sector nor in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries) and/or in a single currency and/or in a single economic sector.

Within a maximum of one-third of its net assets, the Sub-Fund may invest in any other type of eligible assets, such as money market instruments, debt securities (including convertible bonds), structured products, undertakings for collective investment (UCIs) and cash.

However, the Sub-Fund may invest directly in the assets listed below, subject to the following limits:

- Maximum 10% of its net assets in UCIs;
- Maximum 10% of its net assets in closed-ended REITs;
- Maximum 10% of its net assets in contingent convertible bonds;
- Maximum 5% of its net assets in debt securities unrated and/or graded below Standard & Poor's rating of BBB- or an equivalent rating issued by another rating agency;

- Maximum 10% of its net assets in structured products (other than convertible bond type instruments), such as but not limited to certificates whose returns are correlated with changes in, among others, equities or debt securities.

For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over-the-counter. Nevertheless, in normal market conditions, the investment manager intends to use futures and options offering an exposure to equities, financial indices and currency derivatives.

If the investment manager considers this to be in the best interest of the shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also, hold, up to 100% of its net assets, liquidities as among others cash deposits, money market UCIs (under the above-mentioned 10% limit) and money market instruments.

Dealing Frequency

The net asset value for the Class is calculated on each business day in Luxembourg (Calculation Day) based on the pricing of the preceding business day (Valuation Day). The cut-off time to transmit the subscriptions and/or redemptions orders is 12.00 p.m. on the Valuation Day.

Distribution Policy

The Class is cumulative. No dividend will normally be distributed.

Currency

The currency of the Class is CHF.

This is a currency hedged class. It aims to reduce the impact on your investment of movements in the exchange rate between the Sub-Fund currency and the Class currency.

Minimum Investment

The minimum subscription amount is 1'000'000 CHF.

The Class is reserved for institutional investors.

Why is this Sub-Fund in this category?

The portfolio of this Sub-Fund consists essentially of worldwide equities or equity related securities of companies that have adopted a circular business model. The objective of the Sub-Fund is to achieve long term capital growth by using equity-linked investment strategies that will structurally benefit from the shift from a linear to a circular economy. Hence, the risk/reward profile of the Sub-Fund should correspond to a High risk category on the risk/reward scale.

Are there any other particular Risks?

Risks that could affect fund performance and are not necessarily fully reflected in the risk and reward rating include:

- **Liquidity risks:** The Sub-Fund may invest part of its assets in less liquid securities. Those are securities that cannot easily be sold or exchanged for cash without a substantial loss in value in certain market conditions. Those securities also cannot be sold quickly because of a lack of ready

and willing investors or speculators to purchase the asset.

- **Counterparty risks:** The Sub-Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Sub-Fund.
- **Credit risks:** The Sub-Fund invests in debt securities. The issuers of these debt securities may become insolvent, which will mean that the securities will lose all or some of their value.
- **Risks from the use of derivatives:** The Sub-Fund may use financial derivatives instruments which may result in the Sub-Fund being leveraged and may result in material fluctuations in the value of the Sub-Fund. Leverage on certain types of transactions including derivatives may impair the Sub-Fund's liquidity, cause it to liquidate positions at unfavourable times or otherwise cause the Sub-Fund not to achieve its intended objective.

Leverage occurs when the economic exposure created by the use of derivatives is greater than the amount invested resulting in the Sub-Fund being exposed to a greater loss than the initial investment.

- **Operational risks:** The Sub-Fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the management company or by external third parties or may be damaged by external events, such as natural disasters.
- **Sustainability risk:** This risk is any environmental social or governance event or condition that could impact the value of investments. The Investment Manager primarily relies on its ESG analysis and climate risk indicators to categorise the potential level of Sustainability risks in each fund. The level of sustainability risk may fluctuate depending on which investment opportunities the Investment Manager identifies. This means that the fund is exposed to Sustainability Risk which may impact the value of investments over the long term.

Charges

The percentage of ongoing charges is based on the last year's expenses, ending 31/12/2021. This figure may vary from year to year. It excludes:

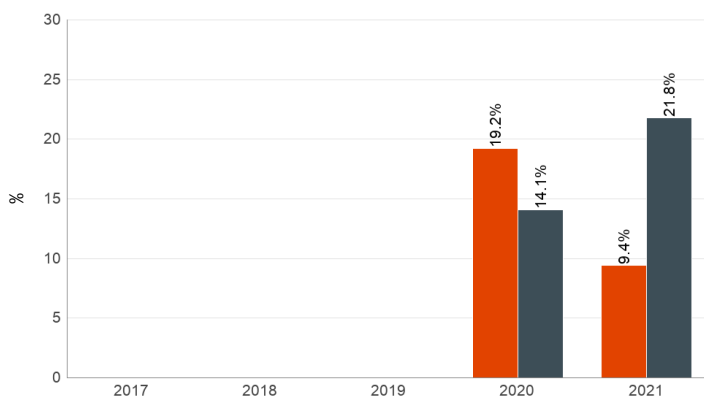
- Performance fees (if applicable)
