What is this product?

Type

Distribution share of a sub-fund of DPAM B, a public SICAV under Belgian law. The shares of the sub-fund are distribution shares, which give right to a dividend. All income earned by the product can be distributed.

Duration

Indefinite. This product does not have a fixed maturity date.

Objectives

Objective: The objective of the sub-fund is to offer you exposure to equity securities of companies involved in the agri-foodstuffs sector (broadly construed). The sub-fund promotes a combination of environmental and social aspects within the meaning of Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector, and must contain a minimum proportion of sustainable investments within the meaning of the same Regulation. This is an actively managed sub-fund. No benchmarks are used in the management of the sub-fund.

Investment policy: The fund mainly invests (without any geographical restriction) in shares and/or other equity securities of companies involved in the production-distribution chain of the agri-foodstuffs sector and other related sectors. The selection is based on a methodology that: -excludes companies not in compliance with certain global standards, including the UN Covenant (human rights, labour rights, environmental protection and anti-corruption), -excludes companies involved in controversial activities (tobacco, gambling, thermal coal) or involved in major ESG controversies (incidents, allegations related to environmental, social, governance issues), is based on an analysis and rating of the ESG profile of the invested company using ESG Scorecards (grids analysing the most relevant and material ESG risks to which companies are exposed) and -aims to achieve impact and sustainability by ensuring that the company's products and/or services finance - as a proportion of its turnover - sustainable agriculture. Derivative products: The sub-fund may, on an optional basis, use derivatives such as futures and/or forwards in order to achieve the investment objectives and/or for hedging purposes (hedging of or exposure to the risks associated with certain markets).

This product is intended for investors with an investment horizon of 6 years meet the criteria for access to this share class described in the prospectus and that:

- are interested in an investment that promotes environmental and social characteristics with a minimum proportion of sustainable investments
- can suffer a loss of more than 20% per year

DPAM B is an undertaking for collective investment in transferable securities incorporated in Belgium (the Home Member State of the SICAV), which complies with the requirements of Directive 2009/65/EC and which is subject to prudential supervision by the FSMA.

In accordance with the applicable legal provisions, the assets of the subfund are segregated from the assets of the other sub-funds of the SICAV, which means that the rights of the investors and other creditors of this subfund are limited to the assets thereof.


The prospectus and periodic reports are drawn up for all the sub-funds of the $\ensuremath{\mathsf{SICAV}}.$

What are the risks and what could I get in return?

Risk Indicator

The risk indicator assumes that you will hold the product for at least 6 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 4 out of 7, which is a medium risk class. In other words, the potential losses related to the future performance of the product are average.

Investing in this product also entails risks that are materially relevant but not included in the risk indicator:

Concentration risk: As the portfolio is mainly composed of securities from specific themes without any geographical restrictions, it is likely to be more specifically exposed to the economic development of these sectors.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

What happens if DPAM is unable to pay out?

The assets of the sub-fund are held with the Custodian and maintained separate from the other assets held by the Custodian.

In the event of a default by DPAM or any other sub-fund of the SICAV, neither of them may use the funds of the product to pay their debts.

However, your investment is not protected by an indemnification or guarantee mechanism.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

If you change sub-funds, you will pay any difference between the marketing fee for the sub-funds in question.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- \bullet In the first year, you would get back the amount that you invested (0 % annual return)
- the other holding periods we have assumed the product performs as shown in the moderate scenario
