## Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to achieve the highest possible appreciation of capital. To achieve this, the fund invests in interest-bearing securities, equities, certificates, funds and banks balances. At least 65% of the investment fund's assets must be invested in interest-bearing securities such as government bonds, corporate bonds or convertible bonds of domestic and foreign issuers, in certificates on bonds or bond indices or in bond funds. Of this portion, at least 51% of the corresponding investment ratio must be invested in securities that are denominated in euro or hedged against the euro

and have investment grade status at the time the securities are purchased. Up to 35% of the investment fund's assets may be invested in equities, equity funds, equity certificates, as well as in certificates on commodities and commodity indices. Up to 35% of the fund's assets may be invested in money market instruments, money market funds and money market funds with short maturity structures or bank balances, respectively. The selection of the individual investments is at the discretion of the fund management. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.


