Objectives and Investment Policy

Investment objective: The Sub-Fund's investment objective is to outperform its benchmark of the Sub-Fund's capital by investing its assets in equities of companies that meet environmental, social and governance (ESG) criteria, and whose activities are predominantly linked to China.

Benchmark index: The benchmark index of the Sub-Fund is the MSCI China 10/40 Net Return Index, calculated with net dividends reinvested

The benchmark index serves only for comparison purposes. The Sub-Fund is actively managed.

Investment policy: The Sub-Fund aims selecting Chinese companies, with a focus on a good management of environmental, social and governance (ESG) risks and opportunities. The Sub-Fund's investment process entails, to this aim, a proprietary responsible investing approach which favours ESG well rated companies irrespective of their capitalizations.

At least 90% of the companies in the portfolio will have an ESG rating.

The selection process includes a positive screening by selecting through a best in universe approach and a negative screening, whereby the Investment Manager has established a formal exclusion policy that integrates the exclusion of controversial companies related to weapons, coal and tobacco. The eligible investment universe is consequently reduced by 20% and defined according to ESG criteria. The Sub-Fund Classifies as Article 8(1) SFDR as it promotes a combination of ESG characteristics, although no reference benchmark has been designated for the purpose of attaining the environmental or social characteristics.

Environmental, social and governance (ESG) criteria are one of the components subject to management and are factored in the final investment decision, although their weighting is not defined beforehand.

In view of its ESG strategy, the Sub-Fund promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation.

The investment strategy is based on the selection and dynamic management of securities of companies that carry out most of their business in China. Between 75% and 110% of the Sub-Fund's net assets will be exposed to equities and other similar securities traded on regulated markets of companies listed, headquartered or with main business in China. The Sub-Fund will invest in China A Shares via the Shanghai-Hong Kong Stock Connect program and in China B Shares listed on the Shanghai and Shenzhen stock exchanges and in equity securities listed on other stock exchanges such as Hong Kong, New York, Singapore and Taipei. Assimilated securities are ADR (American Depositary Receipts), GDR (Global Depositary Receipts), P-Notes (Participatory Notes) (except P-Notes having China A shares held via QFII or RQFII quotas as underlying assets) and certificates of participation.

The scope of securities in which the Sub-Fund invests will be focused, but not limited to, equities of companies whose capitalisation is greater than USD 500 million, covering all sectors. The sectorial diversification of the Sub-Fund helps to limit the portfolio's volatility.

For cash management purposes, the Sub-Fund may invest up to 25% of its net assets in transferable debt securities, Money Market Instruments and Money Market Funds.

The Sub-Fund may use financial derivative instruments to achieve its investment.

The recommended minimum investment period is 5 years.

Frequency of share buying or selling: Every Luxembourg and France bank business day except for Good Friday, 24 December (Christmas Eve) and the days on which the French markets are closed (official calendar of Euronext Paris S.A.) and Chinese markets (official calendar of the Hong Kong Stock Exchange) for orders received by the transfer agent on each NAV calculation day before 4:30 p.m. and processed on the basis of the next net asset value.

Significant risks not taken into account in this indicator:

<u>Credit risk</u> : When a significant level of investment is made in debt securities.

Liquidity risk : The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Sub-Fund, both in the realisation of the prices quoted and the execution of orders at desired prices.

<u>Impact of techniques such as derivative contracts</u>: The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

<u>Counterparty risk</u>: Where a Fund is backed by collateral or has significant investment exposure through contracts with a third party.

<u>Operational risk</u>: The Sub-Fund may suffer losses due to the failure of operational processes, including those related to the safekeeping of assets.

The occurrence of any of these risks may negatively impact the net asset value.



Performance fee

The performance fee is set at 15% and is calculated by comparing the Sub-fund's share performance with that of an indexed reference asset, over the relevant Calculation Period. This fee is due even in the case of a reduction in the Net Asset Value provided that the decrease in Net Asset Value is less than the decrease in the benchmark index. The calculation method is described in the prospectus (outperformance model 2). Payable annually on June 30.

Past Performance



Charges and fees are paid to cover the operating costs of the Sub-Fund, including the cost of marketing and distributing share classes. These costs reduce the potential growth of your investment.

Investors may obtain the actual amount of entry and exit charges from their advisor or distributor. In certain cases you might pay less.

The ongoing charges figure is based on the last year's expenses, for the year ending in December 2021. This figure may vary from year to year. It excludes performance fees and intermediary fees except entry and exit charges paid by the Sub-Fund when buying or selling units and/or shares of another UCI.

The performance fee paid for the preceding exercise closing on June 2021 represents 0.20% of net assets.
