characteristics. In view of its ESG strategy, the Product promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation. The investment strategy is based on the selection and dynamic management of securities of companies that carry out most of their business in China. Between 75% and 110% of the Product's net assets will be exposed to equities and other similar securities traded on regulated markets of companies listed, headquartered or with main business in China. The Product will invest in China A Shares via the Shanghai-Hong Kong Stock Connect program and in China B Shares listed on the Shanghai and Shenzhen stock exchanges and in equity securities listed on other stock exchanges such as Hong Kong, New York, Singapore and Taipei. Assimilated securities are ADR (American Depositary Receipts), GDR (Global Depositary Receipts), P-Notes (Participatory Notes) (except P-Notes having China A shares held via QFII or RQFII quotas as underlying assets) and certificates of participation. The scope of securities in which the Product invests will be focused, but not limited to, equities of companies whose capitalisation is greater than USD 500 million, covering all sectors. The sectorial diversification of the Product helps to limit the portfolio's volatility. For cash management purposes, the Product may invest up to 25% of its net assets in transferable debt securities, Money Market Instruments, term deposits and Money Market Funds. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Credit risk : When a significant level of investment is made in debt securities.
