### What is this Product?

The Product is a sub-fund of EDMOND DE ROTHSCHILD FUND, a public limited liability company (société anonyme), incorporated as a "société d'investissement à capital variable" under Part I of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment and qualifying as an undertaking for collective investment in transferable securities (UCITS)

#### Term

#### Objectives

Objective: The objective of the Product is to achieve long-term optimum growth of the invested capital via investments in regulated capital and money markets. In particular, the Product aims to outperform its benchmark

Benchmark index: The benchmark index of the Product is the JP Morgan CEMBI Broad Diversified Index, hedged in EUR
The benchmark index serves only for comparison purposes. The Product is actively managed.

Investment policy: The Investment Manager will systematically include environmental, social and governance (ESG) factors in their financial analysis in order to select the portfolio's securities.

The actual risk can vary significantly if you cash in at an early stage and you may get back less. In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator),

Credit risk: When a significant level of investment is made in debt securities.

<u>Liquidity risk</u>: The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Product, both in the realisation of the prices quoted and the execution of orders at desired prices.

# What happens if Edmond de Rothschild Asset Management (Luxembourg) is unable to pay out?
