What is this product?

Type

The product is a share class of the sub-fund Franklin European Total Return Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund. **Objectives**

Investment Objective

The Fund is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to maximise total investment return by achieving an increase in the value of its investments, earning income and realising currency gains over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

 higher-quality debt securities issued by governments, government-related entities and corporations located in Europe and/or in euro-denominated securities of non-European issuers

The Fund can invest to a lesser extent in:

 debt securities of any quality (including lower quality) and denominated in any currency from issuers of any type located outside Europe, including emerging markets

 debt securities of supranational entities, such as the European Investment Bank

• structured products such as mortgage- and asset-backed securities, collateralized debt obligations and collateralized loan obligations

securities in default (limited to 10% of assets)



and corporate bond issuers. The Fund uses a selectivity approach in order to exclude from its portfolio issuers that score in the bottom 20% of each respective investment universe. The Fund's ESG strategy includes working with companies to improve their carbon emissions, water and wastewater strategies. The Fund also applies specific exclusions and will not invest, inter alia, in companies that repeatedly and/or seriously violate the United Nations Global Compact, manufacture controversial weapons or tobacco, or exceed certain thresholds on the use of fossil fuels.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the Bloomberg Euro Aggregate Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark. **Share Class Policy**

For the distribution share class shown in this document, dividend income is distributed to shareholders.

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

Intended retail Investor

The Fund may appeal to investors looking to maximise their investment return with a combination of income, capital appreciation and currency gains by obtaining exposure to debt securities issued by European governments or corporate issuers and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
