## **Objectives and Investment Policy**

Franklin Income Fund (the "Fund") aims to earn income and, secondarily, to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

equity and equity-related securities (including equity-linked notes) issued by companies located in, or doing significant business in, the U.S.
debt securities of any quality (including lower quality) issued by corporations and governments

The Fund can invest to a lesser extent in:

• equity and debt securities traded in the U.S. and issued by corporations located anywhere in the world (limited to 25% of assets)

• equity or debt securities issued by corporations that entitle the holder to receive equity or debt securities of another corporation located anywhere in the world (limited to 25% of assets)

derivatives for hedging, efficient portfolio management and/or investment purposes

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The investment team uses in-depth analysis to select individual securities that it believes are undervalued and will provide the best opportunities for income and increased value over the long term.

The benchmark of the Fund is the Linked Blended 50% MSCI USA High Dividend Yield Index + 25% Bloomberg High Yield Very Liquid Index + 25%

#### **Terms to Understand**

**Debt securities:** Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Equity securities: Securities that represent an ownership stake in a company.

**Hedging:** A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

#### Why is the Fund in this specific category?

The Fund invests mainly in a diversified portfolio of U.S. equity, equityrelated and debt securities. Such securities have historically been subject to price movements that may occur suddenly due to equity market- and bond market-specific factors. As a result, the performance of the Fund can fluctuate considerably over time.

#### Risks materially relevant not adequately captured by the indicator:

**Credit risk:** the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.


