## Objectives and Investment Policy

- The fund seeks to deliver an attractive income and capital growth by investing at least 70% in a broad range of bonds of issuers in the Asia Pacific region that have their head office or exercise a majority of their activity in the Asia Pacific region.
- The fund adopts an active asset allocation approach, which may include investment in high yield instruments.
- Investments will not be required to meet minimum rating standards.
- This region includes countries considered to be emerging markets.
- Less than 30% of the fund's total net assets will be invested in hybrids and Cocos, with less than 20% of the total net assets to be invested in Cocos
- The fund can invest in bonds issued by governments, companies and other bodies.
- The fund has the freedom to invest outside its principal geographies, market sectors, industries or asset classes.
- The fund will invest less than 50% directly and/or indirectly in onshore China fixed income securities, which may include urban investment bonds, asset-backed securities (including asset-backed commercial papers) and bonds which are rated below investment grade or unrated bonds on an aggregated basis.
- Within the main asset classes, the fund may invest up to 100% in emerging markets, up to 90% in high yield instruments, up to 80% in Asia Pacific local currency bonds and up to 50% in offshore China bonds.
- The fund 's exposure to Distressed Securities is limited to 10% of its assets.
- The fund will invest up to 50% directly and/or indirectly in onshore China fixed income securities, which may include urban investment bonds, asset-backed securities (including asset-backed commercial papers) and bonds which are rated below investment grade or unrated bonds on an aggregated basis.
- The fund may invest in assets directly or achieve exposure indirectly through other eligible means including derivatives. The fund can use derivatives with the aim of risk or cost reduction or to generate additional capital or income, including for investment purposes, in line with the fund's risk profile.
- Investments may be made in currencies other than the fund's reference currency. Exposure to currencies may be hedged, for example with currency forward contracts. The fund's reference currency is the currency used for reporting and may be different from the currency of denomination of the investments.
- The reference currency of the fund is hedged to the reference currency of the share class. This hedging has the effect of translating (or "replicating") the returns expressed in the fund's reference currency into returns expressed in the reference currency of the share class.
- The fund is actively managed without reference to an index.
- Income earned by the fund is paid to shareholders out of gross investment income for most of the time. The fund seeks to maintain a stable payment per share so far as is reasonable. The payment is not fixed and will vary according to economic and other circumstances, and the ability of the fund to support stable payments without a long-term positive or negative impact on its capital. This may occasionally result in income payment coming out of the capital.
- The fund's source of income will mainly be generated from coupon payments from bond holdings.
- Shares can usually be bought and sold each business day of the fund.

- There is a risk that the issuers of bonds may not be able to repay the money they have borrowed or make interest payments. While we seek to mitigate this, the fund may be exposed to the risk of financial loss if it invests into an instrument issued by an entity that subsequently defaults on its borrowings. Losses may also be realised if an entity that the fund is exposed to ceases to make interest payments over a period of time or indefinitely. Bond prices have an inverse relationship with interest rates such that when interest rates rise, bonds may fall in value. Rising interest rates may cause the value of your investment to fall.
- Liquidity is a measure of how easily an investment can be converted into cash. Under certain market conditions assets may be more difficult to value or sell at a desired price. This could affect the fund's ability to meet redemptions in a timely manner.
- Emerging markets may be more volatile and it could be harder to sell or trade securities. There may be less supervision, regulation and less welldefined procedures than in more developed countries. Emerging markets can be sensitive to political instability, which can result in greater volatility and uncertainty, subjecting the fund to the risk of losses.


