## What is this product?

### Type

Shares of a sub-fund of Fidelity Funds SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS).

### Term

This fund is open-ended.

### Objectives

**Objective:** The fund aims to achieve capital growth over the long term .

**Investment Policy:** The fund invests in a range of asset classes including equities, corporate and government bonds, commodities, money market instruments and eligible REITs from anywhere in the world, including emerging markets.

The fund may invest in the following assets according to the percentages indicated:

bonds of any type: up to 100%

investment grade bonds: up to 50%

below investment grade and unrated bonds: up to 75%

emerging markets bonds : up to 75%

emerging markets equities: up to 75%

equities: up to 100%

Russian securities: up to 15%

eligible commodity exposure: up to 50%

China A and B shares and listed onshore bonds (directly and/or indirectly): less than 30% (in aggregate)

eligible REITs: up to 30%

hybrids and contingent convertible (CoCo) bonds: less than 30%, with less than 20% in CoCos

SPACs: less than 5%.

The fund may also invest in other subordinated financial debt and preference shares.

The fund's exposure to distressed securities is limited to 10% of its assets.

**Investment Process:** In actively managing the fund, the Investment Manager will tactically allocate investments across asset classes and geographic areas (including emerging markets) based on their potential to generate capital growth or reduce overall risk.

The Investment Manager takes into account Sustainability Risks in its investment process.

**Derivatives and Techniques:** The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

This product may appeal to investors with a basic knowledge of and no or limited experience of investing in funds; who plan to hold their investment for a recommended holding period of at least 3 years; who seek capital growth over the recommended holding period and; and who understand the risk of losing some or all of the capital invested.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 3 years.  
The actual risk can vary significantly if you cash in at the early stage and you may get back less.

## What are the costs?
