# WHAT IS THIS PRODUCT?

**Type:** The product is a share class of the Flossbach von Storch - Global Convertible Bond sub-fund, which is part of the Flossbach von Storch fund, a Luxembourg investment fund (fonds commun de placement – FCP) that has been established in the form of an umbrella fund and is subject to Part I of the Luxembourg Law of 17 December 2010 (Law of 2010), as amended, and thus qualifies as a UCITS. The assets and liabilities of each sub-fund are segregated by law.

**Term:** The product has an unlimited term. Notwithstanding this, the product may at any time be liquidated by the Management Company. As a rule, investors can redeem their units on any Luxembourg banking day except 24 and 31 December. The manufacturer may suspend redemption if exceptional circumstances make this appear necessary when investor interests are taken into account.

### **Objectives:**

The objective of the investment policy of Flossbach von Storch - Global Convertible Bond (the "sub-fund") is to achieve reasonable growth while taking into consideration the risk involved for the investors. The sub-fund is actively managed. The Refinitiv Global Focus Hedged CB (EUR) Index is used as a reference for comparing the performance of the sub-fund. For unit class currencies other than the euro, the index in the same currency is used. The fund manager is not bound to the index at any time when making investment decisions. The performance of the sub-fund can therefore deviate significantly from the benchmark.

The investment policy of the sub-fund is aimed at achieving an attractive investment result in the long term by investing predominantly in international convertible bonds and similar securities that offer a reduced risk compared to direct equity investments. In addition to interest income from bonds, the result should also be primarily determined by the profit potential from the option to convert bonds into equities. The investment focus is on convertible bonds and other structured products from companies that exhibit good income and price potential and solid financing. An investment may involve a mixture of equities, bonds, certificates, units in UCITS or other UCI ("target funds") and fixed-term deposits. Securities may be acquired worldwide, including from all OECD countries, with investments in emerging countries restricted to 49% of the sub-fund's net assets. Target funds will be acquired only up to a maximum limit of 10% of the sub-fund assets. The use of derived financial instruments ("derivatives") is planned in order to achieve the aforementioned investment objectives, as well as for investment and hedging purposes. The current sales prospectus provides detailed information on the above and other investment opportunities available to the sub-fund. This sub-fund may not be suitable for investors that want to withdraw their capital from the sub-fund within a period of 5 years. This unit class distributes the income it generates to investors.

The sub-fund promotes environmental and social characteristics as defined in Article 8 of Regulation (EU) 2019/2088. Flossbach von Storch follows a holistic sustainability approach across the group: As a long-term investor, Flossbach von Storch attaches importance to companies dealing responsibly with their environmental and social footprint and actively counteracting negative impacts of their activities.



**Summary Risk Indicator**

# WHAT HAPPENS IF FLOSSBACH VON STORCH INVEST S.A. IS UNABLE TO PAY OUT?

The sub-fund assets are segregated from the assets of the Management Company. The Depositary is responsible for holding the assets of the fund in safekeeping. If the Management Company defaults, it will have no direct financial effect on the sub-fund. In addition, the sub-fund assets are segregated from the assets of the Depositary, which reduces the risk of the sub-fund suffering a loss if the Depositary defaults. There is no investor compensation or guarantee scheme if the Management Company or the Depositary defaults.
