# What is this product?

# Type

Focused SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

# Objectives

The actively managed fund invests predominantly in USD bonds issued by the International Bank for Reconstruction and Development ("IBRD"). The average remaining term of the total portfolio is a maximum of 6 years. This sub-fund has sustainable investment objectives. The fund uses the benchmark Solactive Global Multilateral Developement Bank Bond USD 1-5 TR Index as a reference for portfolio construction, performance comparison and risk management.

The fund's return depends primarily on the development of interest rates, the creditworthiness of issuers and interest income. The return can also be influenced by exchange rate fluctuations if there are active or unhedged positions. The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged

against the currency of the fund.

# Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What are the costs?
