### Objectives and Investment Policy

Franklin Gold and Precious Metals Fund (the "Fund") aims to increase the value of its investments and, secondarily, to earn income over the medium to long term.

The Fund invests mainly in:

- equity and equity-related securities issued by companies of any size and in any country, including emerging markets, that are involved in the mining, processing or trading of gold and other precious metals

The investment team looks for equity securities that it believes will benefit from rising gold and other precious metals prices over the long term.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

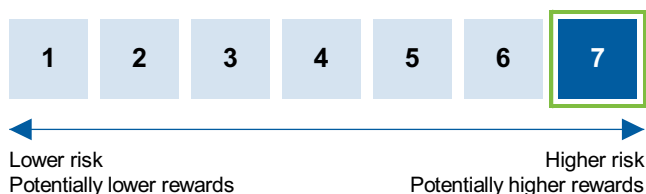

#### Why is the Fund in this specific category?

The Fund invests mainly in equity and equity-related securities of gold and precious metal companies in both developed and emerging countries. Such

securities have historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can fluctuate very significantly over relatively short time periods.

#### Risks materially relevant not adequately captured by the indicator:

**Currency risk:** the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

**Emerging markets risk:** the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

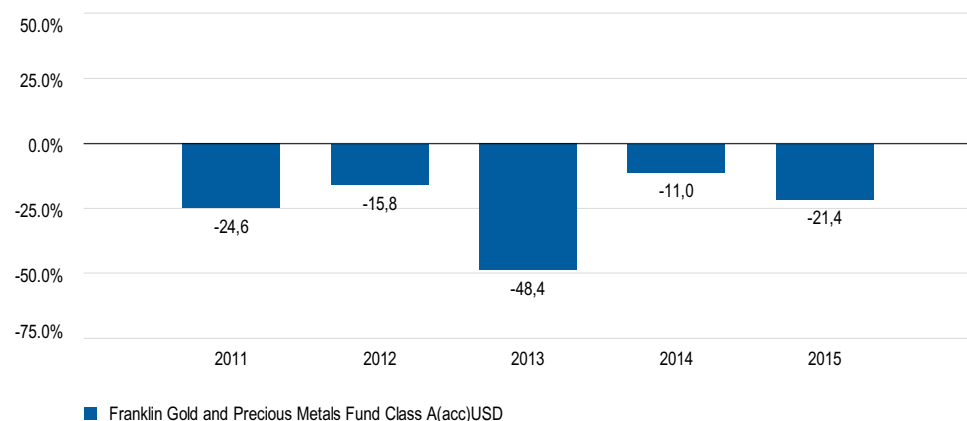
