What is this product?

Type

The product is a share class of FTGF ClearBridge US Aggressive Growth Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment ObjectiveThe Fund's investment objective is to generate long-term capital appreciation.

Investment Policy

- The Fund invests at least 70% of its net asset value in common stocks of US companies which are listed or traded on regulated markets in the United States listed in the Prospectus and that the investment manager believes are experiencing, or have potential to experience, growth of earnings and/or cash flow that exceed the average of companies having securities included in the S&P 500 Index.
- The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.
- The Fund may also invest up to 20% in companies outside of the US.
- This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.
- Benchmark: Russell 3000 Growth Index and S&P 500 Index
- Manager's Discretion: The Fund is actively managed. The investment manager has discretion in selecting investments within the Fund's objective and investment policies. The benchmarks are used for performance

comparison purposes. The Russell 3000 Growth Index is considered the Fund's primary benchmark because it consists of growth securities, which is aligned with the investment manager's focus on growth securities in managing the Fund. The performance of the S&P 500 Index may also be provided because it is considered a proxy for the US equity market. While most of the Fund's securities will be components of one or both benchmarks, the weightings of the holdings may differ materially from the weightings in the benchmarks. The Fund may also invest in securities that are not included in the benchmarks. The Fund's percentage exposures to sectors and industries may differ materially from those of the benchmarks.

• Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

For this share class all, or some portion of, net income is declared and paid annually to shareholders.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to achieve capital appreciation by obtaining exposure to equity securities US issuers with the investment manager believes are experiencing or have the potential to experience growth above the rate of the S&P 500 Index. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
