# What is this product?

#### Type

The product is a share class of FTGF ClearBridge US Large Cap Growth Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

# Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### **Objectives**

### **Investment Objective**

The Fund's investment objective is to generate long-term capital appreciation.

#### **Investment Policy**

- The Fund will invest up to 70% in shares of large US companies. The Fund's investments will consist of common stocks and to a lesser extent preferred stock and equity-related securities issued by or related to large market capitalisation US companies, which are believed to afford attractive opportunities for investment growth. The Fund may also invest in aggregate up to 30% of its net asset value in money market Instruments; equity and equity related securities of US or non-US Companies irrespective of market capitalisation; debt securities; non-publicly traded securities and mortgage-backed or asset-backed securities.
- The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.
- This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation
- Benchmark: Russell 1000 Growth Index and S&P 500 Index

- Manager's Discretion: The Fund is actively managed. The investment manager has discretion in selecting investments within the Fund's objective and investment policies. The benchmarks are used for performance comparison purposes. While most of the Fund's securities will be components of one or both benchmarks, the weightings of the holdings may differ materially from the weightings in the benchmarks. The Fund may also invest in securities that are not included in the benchmarks. The Fund's percentage exposures to sectors and industries may differ materially from those of the benchmarks.
- Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

### Intended retail Investor

The Fund may appeal to investors looking to achieve capital appreciation by obtaining exposure to equity securities of large US issuers which the investment manager believes are dominant in their respective industry. Investors should be willing to hold their investment over the long term for a minimum period of 5 to 7 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

# Risk Indicator

### What are the costs?

#### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
