What is this product?

Туре

The product is a share of the sub-fund Franklin Global Convertible Securities Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund. **Objectives**

Investment Objective

The Fund aims to increase the value of its investments and to earn current income over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

 convertible securities of any quality issued by corporations of any size located in any country (including lower quality securities such as unrated, non-investment grade securities and securities in default) and common stock received upon conversion of convertible securities

The Fund can invest to a lesser extent in:

 equity or equity-related securities issued by companies of any size located in any country

 debt securities of any quality issued by corporations of any size located in any country (including lower quality securities such as unrated, noninvestment grade securities and securities in default)

 derivatives for hedging, efficient portfolio management and/or investment purposes

structured products (such as equity-linked securities)

• units of other mutual funds (limited to 10% of assets)

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 3 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The Fund aims to maximise total return through a combination of capital appreciation and income under varying market conditions. The investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the Refinitiv Global Focus Convertible Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

Intended retail Investor

The Fund may appeal to investors looking to maximise their investment return with a combination of capital appreciation and income by obtaining exposure to convertible securities of corporate issuers worldwide and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Morgan SE, Luxembourg branch. What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
