What is this product?

The product is a share of the sub-fund Franklin Global Fundamental Strategies Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund. **Objectives**

Investment Objective The Fund aims to increase the value of its investments and, secondarily, to earn income over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

- · equity securities issued by companies of any size that are leaders in innovation, take advantage of new technologies, have superior management and benefit from new industry conditions in the dynamically changing global economy, located in any country, including emerging
- debt securities of any quality (including low rated or sub-investment grade securities) issued by governments, government-related entities and corporations located in any country

The Fund can invest to a lesser extent in:

- · convertible securities and up to 5% of the Fund's assets in contingent convertible securities
- · derivatives for hedging, efficient portfolio management and investment

- units of other mutual funds (limited to 10% of assets)
- mortgage- and asset-backed securities (limited to 10% of assets)
- · Mainland China through the Bond Connect or directly (limited to 30% of assets)

The investment team aims to divide the Fund's assets among four different investment strategies: two that look for equity securities worldwide (representing approximately 60% of assets) and two that focus on debt securities worldwide (representing approximately 40% of assets).

The Fund is not managed in reference to a benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

For this share class, the manager applies a portfolio hedge that is intended to minimize the currency risk between the currency of the share class (which is in a non-base currency) and the base currency of the Fund.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day.

Intended retail Investor

The Fund may appeal to investors looking to capital appreciation and to a lesser extent, to seek income, by obtaining exposure to a diversified portfolio of equity and debt securities worldwide and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.



What are the risks and what could I get in return?

Risk Indicator
