### Objectives and Investment Policy

Franklin Japan Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size located in, or doing significant business in, Japan

The investment team evaluates each company, considering factors such as management quality and growth prospects. The investment team also considers economic trends that may affect security prices.

The benchmark of the Fund is the Tokyo Stock Price Index (TOPIX). The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint

on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

You may request the sale of your shares on any Luxembourg business day.

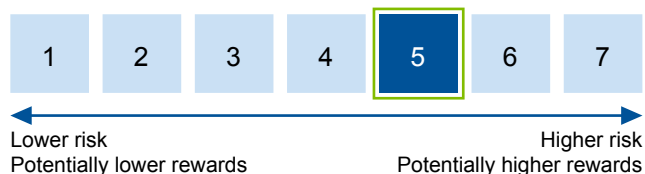
The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

#### Why is the Fund in this specific category?

The Fund invests mainly in Japanese equity securities. Such securities have historically been subject to significant price movements that may occur suddenly due to market or company-specific factors. As a result, the performance of the Fund can fluctuate considerably over time.

#### Risks materially relevant not adequately captured by the indicator:

**Concentration risk:** the risk that arises when a fund invests in relatively few holdings, few sectors or a restricted geographic area. Performance may be more volatile than a fund with a greater number of securities.

**Foreign Currency risk:** the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

**Liquidity risk:** the risk that arises when adverse market conditions affect the ability to sell assets when necessary. 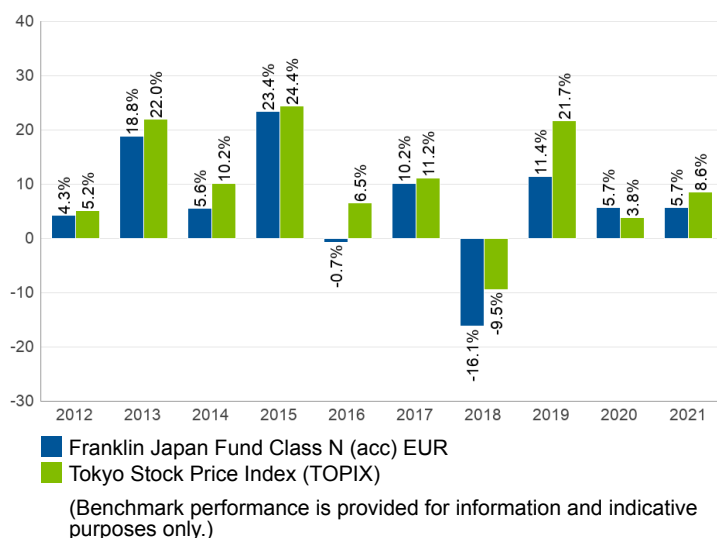
