Objectives and Investment Policy

Templeton China Fund (the “Fund”) aims to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity securities issued by companies of any size located in, or doing significant business in, China, Hong Kong and Taiwan

The Fund can invest to a lesser extent in:

- equity securities for which the principal markets for trading are China, Hong Kong and Taiwan, or whose performance relates to assets in, or currencies of, those countries
- equity or debt securities issued by companies of any size located in any country, including other emerging markets

The investment team uses in-depth financial analysis to select individual

securities that it believes will provide the best opportunities for increased value over the long term.

You may request the sale of your shares on any Luxembourg business day.

For distribution share class shown in this document, dividend income is distributed to shareholders.

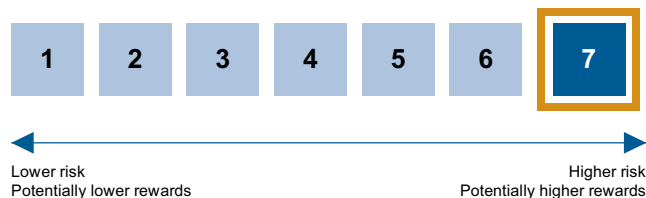
Terms to Understand

Debt securities: Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Equity securities: Securities that represent an ownership stake in a company.

Why is the Fund in this specific category?

The Fund invests mainly in Chinese equity securities. Such securities have

historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can fluctuate very significantly over relatively short time periods.

Risks materially relevant not adequately captured by the indicator:

Currency Risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

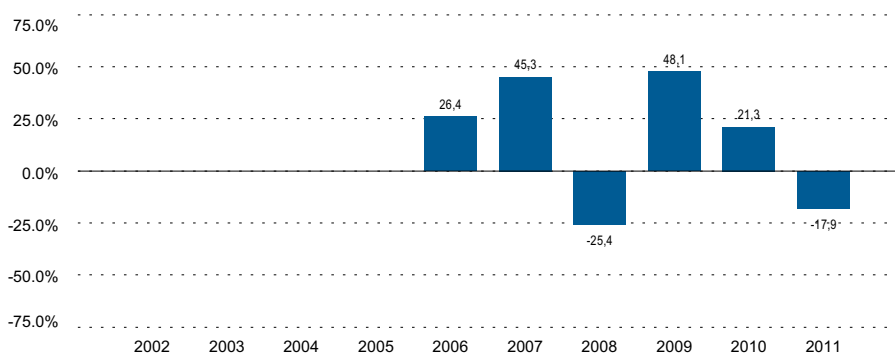
The entry charges shown are maximum amounts; you may pay less in some cases. For more information, please see your financial adviser.
