#### **Objectives and Investment Policy**

Templeton Global Balanced Fund (the "Fund") aims to increase the value of its investments and to earn income over the medium to long term.

The Fund invests mainly in:

- equity and equity-related securities issued by companies of any size located in any country, including emerging markets
- debt securities issued by government and corporate issuers located in any country, including emerging markets (limited to 40% of assets)

Two separate teams using different strategies manage the Fund's equity and debt portfolios. The equity team uses in-depth analysis to select individual securities that it believes are significantly undervalued and will provide the best opportunities, over the long term, for increased value. The debt securities team evaluates each issuer individually while also looking at broad-based trends.

You may request the sale of your shares on any Luxembourg business day.

For the accumulation share class shown in this document, dividend income is reinvested in the Fund.


#### **Terms to Understand**

**Debt securities:** Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

**Emerging markets:** Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Equity securities: Securities that represent an ownership stake in a company.

## Why is the Fund in this specific category?

The Fund invests mainly in equity, equity-related and debt securities around the world. Such securities have historically been subject to significant price movements that may occur suddenly due to equity and bond market or

company-specific factors. As a result, the performance of the Fund can fluctuate considerably over time.

#### Risks materially relevant not adequately captured by the indicator:

**Credit risk:** the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

**Currency risk:** the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.


