What is this product?

Type

The product is a share class of FTGF Western Asset Short Duration Blue Chip Bond Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund's investment objective is to achieve total return, through income and capital appreciation.

Investment Policy

- The Fund invests mainly in higher rated corporate bonds (rated A- or higher by S&P or the equivalent by another NRSRO, or if unrated deemed to be of comparable quality) issued in certain developed countries.
- The Fund will only invest in those corporate bonds that have priority over certain other bonds in a claim against the issuer.
- The Fund may invest in bonds issued by international organisations.
- The Fund may invest in securities denominated in any currency; however, the Fund will attempt to hedge all non-US Dollar positions to the US Dollar, so that the fund is not exposed to any currencies other than the US Dollar.
- The Fund may invest in derivatives (financial instruments whose value is derived from the value of other assets), to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.
- This is an Article 8 fund under the EU Sustainable Finance Disclosure Regulation.
- Manager's Discretion: The Fund is actively managed. The investment manager has discretion in selecting investments within the Fund's objective and investment policies.

• Transaction Costs: The Fund bears costs in buying and selling investments, which may have a material impact on the Fund's performance. A benchmark is not used for performance comparison purposes.

Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class certain fees and expenses may be charged to capital rather than income. This will result in an increase in income available for distribution by foregoing some of the capital that the share class would have available for future investment and potential growth. In addition, all or some portion, of realised and unrealised capital gains net of realised and unrealised capital losses may be declared as a dividend.

Processing of subscription and redemption orders

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

The Fund may appeal to investors looking to achieve total return with a combination of income and capital appreciation by obtaining exposure to high quality corporate debt securities globally, excluding emerging markets that are deemed 'blue chip' (debt rating of A- of high by S&P or equivalent). The debt securities purchased are expected to have an average portfolio duration of 0 to 5 years. Investors should be willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.



What are the risks and what could I get in return?

Risk Indicator





The risk indicator assumes you keep the product for 5 year(s).

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
